Staff Recommendation: Approve request to amend the text on the face of the Lakeridge
Addition Plat to allow a footbridge to be built on Reserve E.

MAPC Recommendation: Approve request to amend the text on the face of the Lakeridge
Addition Plat to allow a footbridge to be built on Reserve E.
(unanimous)

Background: The applicants wish to amend the text on the face of the Lakeridge Addition Plat to
allow the construction of a footbridge over an existing portion of a lake at the southernmost portion
of the Reserve. Currently, no structures are permitted on Reserve E of this plat. The footbridge
connects a pedestrian path system for the Lakeridge and Landing Homeowners Association.

No one spoke in opposition to this request at the MAPC's advertised public hearing, and the MAPC
voted to approve the vacation, adopting the findings of fact that are incorporated in the Vacation
Order, subject to structures on Reserve E, Lakeridge Addition, shall be limited to one footbridge.
No written protests have been filed.

Legal Considerations: A certified copy of the Vacation Order will be recorded with the Register of
Deeds.

Recommendations/Actions: Follow the recommendation of the Metropolitan Area Planning
Commission and approve the Vacation Order, and authorize the necessary signatures.
