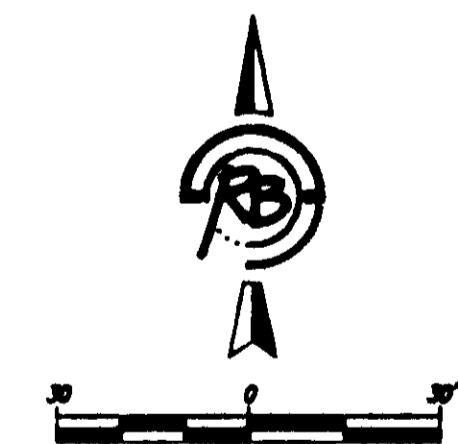
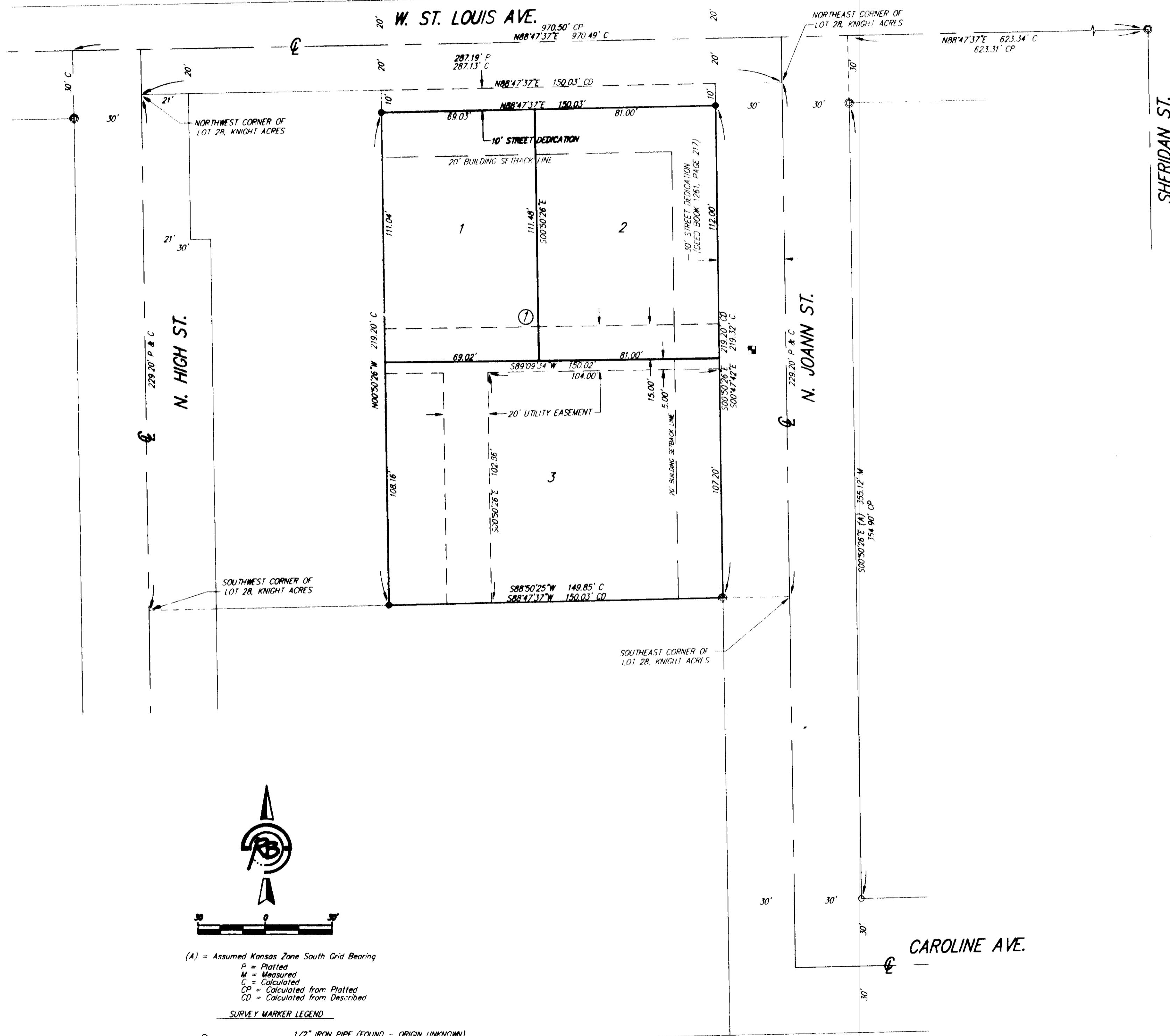

We, Ruggles & Bohm, P.A., Land Surveyors in aforesaid county and state, do hereby certify that, under the supervision of the undersigned, we have surveyed and platted "BATC ESTATES", an Addition to Wichita, Sedgwick County, Kansas, and that the accompanying plat is a true and correct exhibit of the property surveyed, described as follows:

The E1/2 acre of Lot 28, in Knight Acres; and also beginning at the northwest corner of the E1/2 acre of Lot 28; thence West on the north line of said Lot 28, a distance of 85 feet; thence South parallel with the east line of said Lot 28, 229.2 feet to the south line of said Lot 28; thence East on the south line of Lot 28, 85 feet to the southwest corner of the E1/2 acre of said Lot 28; thence North, 229.2 feet to the place of beginning, Sedgwick County, Kansas, EXCEPT the east 30 feet of said Lot 28 dedicated to the public for street purposes.

All public easements and dedications are hereby vacated by virtue of K.S.A. 12-512b.

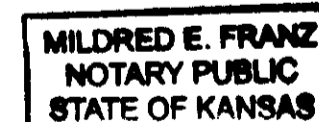
