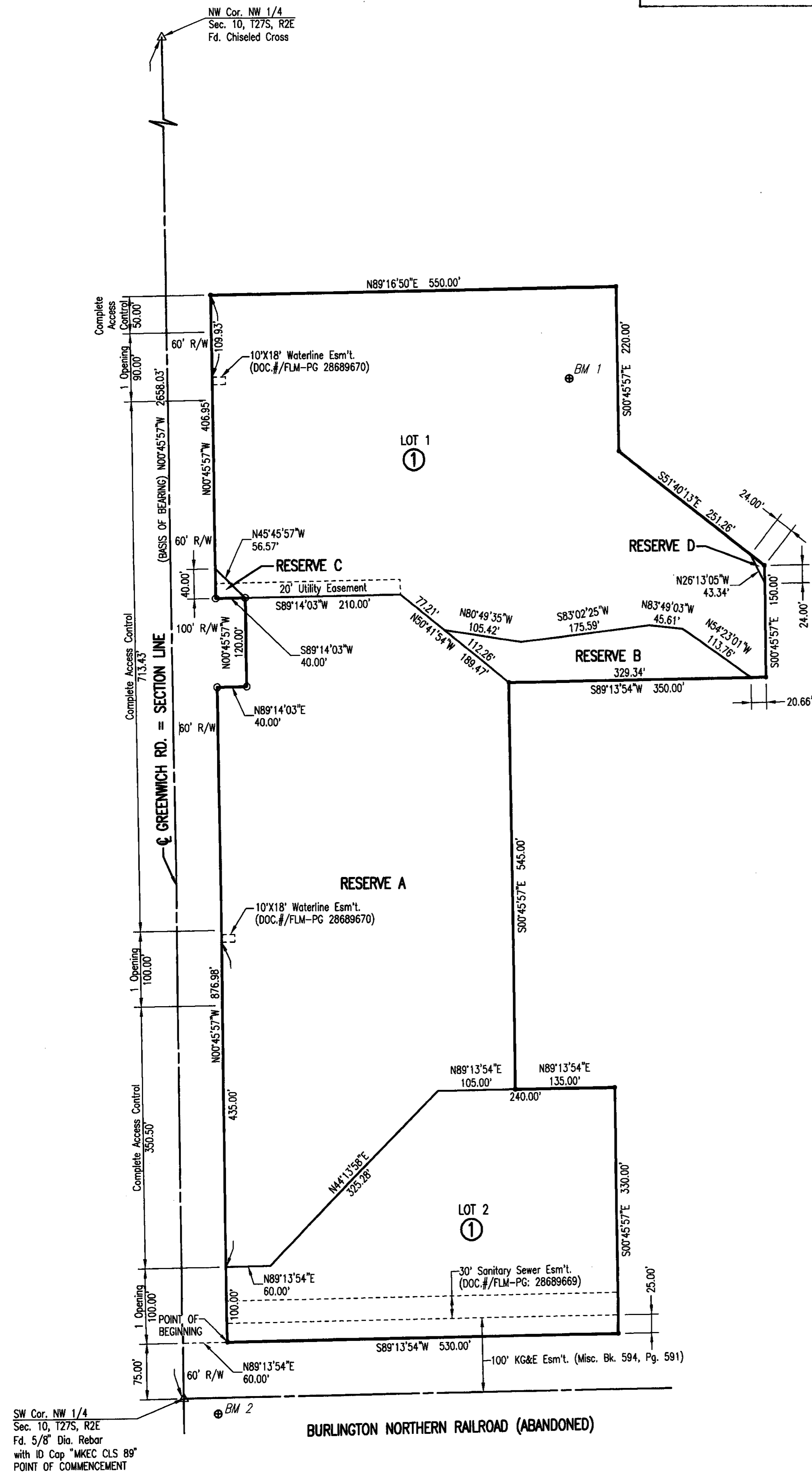

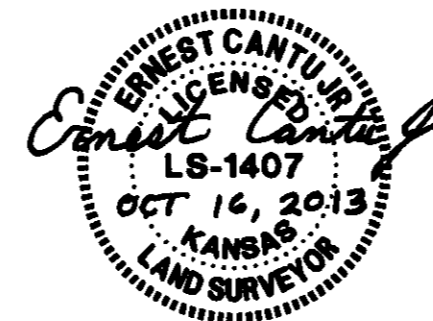

PART OF THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 27 SOUTH, RANGE 2 EAST OF THE SIXTH PRINCIPAL MERIDIAN, SEDGWICK COUNTY KANSAS, DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER; THENCE N00°45'57"W ALONG THE WEST LINE OF SAID NORTHWEST QUARTER A DISTANCE OF 75.00 FEET; THENCE N89°13'54"E, PARALLEL WITH THE SOUTH LINE OF SAID NORTHWEST QUARTER, A DISTANCE OF 60.00 FEET TO THE POINT OF BEGINNING; THENCE BEARING N00°45'57"W PARALLEL WITH THE WEST LINE OF SAID QUARTER SECTION, A DISTANCE OF 876.98 FEET; THENCE N89°14'03"E, A DISTANCE OF 40.00 FEET; THENCE BEARING N00°45'57"W, A DISTANCE OF 120.00 FEET; THENCE BEARING S89°14'03"W, A DISTANCE OF 40.00 FEET, TO A POINT 60 FEET EAST OF THE WEST LINE OF SAID QUARTER SECTION; THENCE BEARING N00°45'57"W, PARALLEL WITH THE WEST LINE OF SAID QUARTER SECTION, A DISTANCE OF 406.95 FEET; THENCE BEARING N89°16'50"E, A DISTANCE OF 550.00 FEET; THENCE BEARING S00°45'57"E, A DISTANCE OF 220.00 FEET; THENCE BEARING S51°40'13"E, A DISTANCE OF 251.26 FEET; THENCE BEARING S00°45'57"E, A DISTANCE OF 150.00 FEET; THENCE BEARING S89°13'54"W, A DISTANCE OF 350.00 FEET; THENCE BEARING S00°45'57"E, PARALLEL WITH THE WEST LINE OF SAID QUARTER SECTION, A DISTANCE OF 545.00 FEET; THENCE BEARING N89°13'54"E, A DISTANCE OF 135.00 FEET; THENCE BEARING S00°45'57"E, A DISTANCE OF 330.00 FEET, TO A POINT 75.00 FEET NORTH OF THE SOUTH LINE OF SAID QUARTER SECTION; THENCE BEARING S89°13'54"W, PARALLEL WITH THE SOUTH LINE OF SAID QUARTER SECTION, A DISTANCE OF 530.00 FEET TO THE POINT OF BEGINNING.

ALL ABUTTERS' RIGHT OF ACCESS TO AND FROM GREENWICH ROAD ARE HEREBY GRANTED TO THE APPROPRIATE GOVERNING BODY; PROVIDED HOWEVER THAT LOT 1, BLOCK 1, SHALL HAVE ACCESS TO GREENWICH ROAD AT ONE LOCATION AND THAT LOT 2, BLOCK 1 SHALL HAVE ACCESS TO GREENWICH ROAD AT ONE LOCATION AND RESERVE "A" SHALL HAVE ACCESS TO GREENWICH ROAD AT ONE LOCATION AS SHOWN.

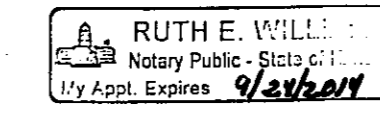

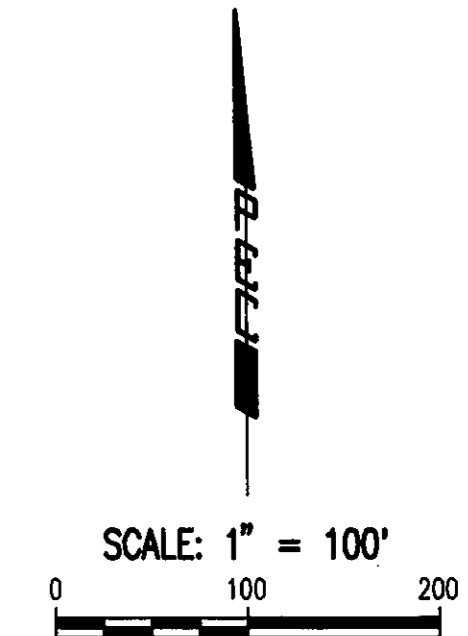

BM 2 - CHISELED "d" ON THE TOP FRONT CENTER OF THE STORM DRAIN CURB INLET ON THE E SIDE OF GREENWICH ROAD AND ON THE N SIDE OF THE RAILS TO TRAILS HIKING PATH FROM THE ABANDONED RAILROAD RIGHT OF WAY BETWEEN 13TH STREET AND 21ST STREET.
