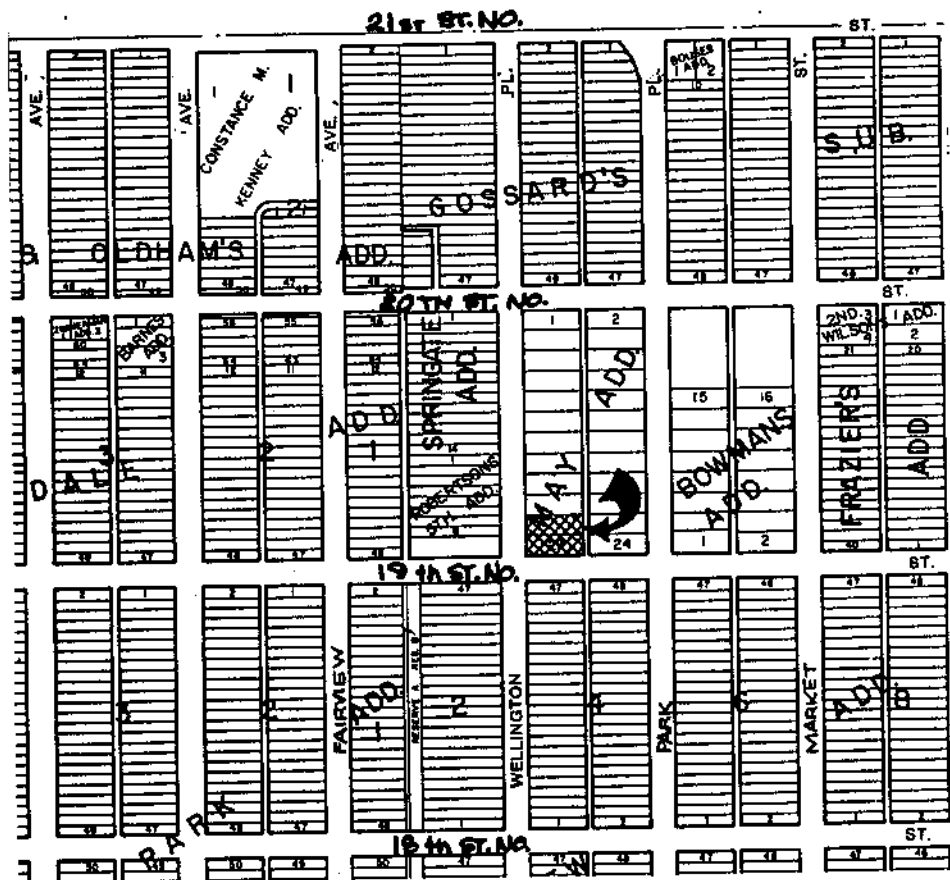

(2004 Wellington Place)



JURISDICTION: The Board has jurisdiction to consider this request under the provisions outlined in Section 2.12.590.C, Code of the City of Wichita. The Board may grant the exception, provided the conditions set out in Section 28.04.185.2 can be complied with.

BACKGROUND: The applicant is requesting a use exception to establish a day care center for up to 12 mentally retarded adults plus two caretakers (supervisors) in a large (2,700 sq. ft.) two-story dwelling at 2004 Wellington Place. The day care center would operate from 9 a.m. to 3 p.m. Monday through Friday. If the related case, BZA 20-89, is approved, this same structure would be used as a group home for 4 other mentally retarded adults who would be away from the facility during the hours of operation of the day care center. The adults who would come to the day care center are from other Cranford Living-Learning Centers in town. They would be transported to and from the center in a van. Adequate paved, on-site parking should be required for this day care center. If the adjacent alley is used for access to the parking, it shall be paved. Whether or not it is used for access, 3 additional feet should be dedicated from this site for alley purposes, as the platted alley width is only 14 feet wide. Current licensing regulations require that clients not spend days and nights in the same facility. An accessory office for the director and secretary of the Cranford Living-Learning Centers to handle the paperwork of the day care center and group home would also be included at this location.

ADJACENT ZONING AND LAND USE:

NORTH	"RB"	One-family dwelling
SOUTH	"RB"	One-family dwelling
EAST	"RB"	One-family dwelling
WEST	"RB"	One-family dwelling

RECOMMENDATION: Should the Board determine that a day care center for up to 12 mentally retarded adults plus two supervisors is appropriate at this location, it is recommended that the exception be approved, subject to the following conditions:

1. This exception for a day care center is for mentally retarded adults only and for a maximum of twelve at any one time (not counting supervisory staff). Any expansion of the facility to accommodate more than twelve clients or clients other than mentally retarded adults will require a new BZA application.
2. The facility shall comply with all state and local codes. The applicant shall obtain all necessary permits and licenses.
3. The accessory office for the Cranford Living-Learning Centers shall accommodate no more than two employees.
4. Paved parking shall be provided on site as follows:
 - 1 space per vehicle used in the operation of the center;
 - 1 space per supervisor;
 - 1 space per employee in the accessory office.

WHEREAS, Cranford Living-Learning Centers, pursuant to Section 2.12.590.C, Code of the City of Wichita, requests an exception to permit an adult day care center for 12 mentally retarded adults plus 2 caretakers on property zoned the "RB" Four-Family Dwelling District and legally described as follows:

Generally located on the northeast corner of 19th

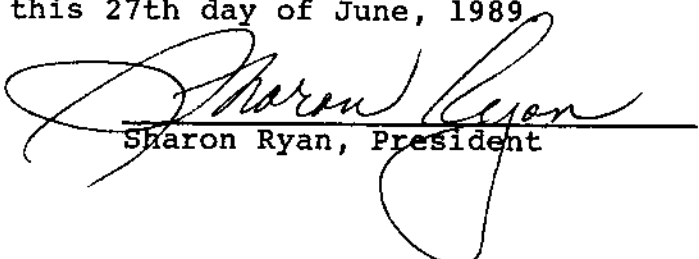

subject to the following conditions:

 - 1 space per vehicle used in the operation of the center;
 - 1 space per supervisor;
 - 1 space per employee in the accessory office.
5. Within 30 days after approval of this use exception by the Board of Zoning Appeals and prior to release of this resolution, the property owners (Evies O. and Sharon H. Cranford) shall dedicate the east 3 feet of the property for alley purposes.
