

ORDINANCE NO. 25-946

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. A tract in the Southeast Quarter of the Southeast Quarter of Section 26, Township 27 South, Range 1 West of the 6th P.M., described as follows:

Beginning 40 feet West of the Southeast corner of the Southeast Quarter of the Southeast Quarter, Section 26, Township 27 South, Range 1 West, thence West along the South line of said Southeast Quarter, of the Southeast Quarter 650 feet, thence North parallel to the East line of said Southeast Quarter of the Southeast Quarter, 1320.8 feet, more or less, to the North line of said Southeast Quarter of the Southeast Quarter, thence East along said North line of said Southeast Quarter of the Southeast Quarter, 350 feet, thence South 630 feet, thence East 300 feet to a point 40 feet West of the East line and 630 feet South of the North line of said Southeast Quarter of the Southeast Quarter, thence South 690.8 feet more or less, to the point of beginning, platted as R. J. Dougherty Addition.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, and 25-939 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-547 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
