ORDINANCE NO. 25-984

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Platted and unplatted tracts in the Northeast Quarter of Section 35, Township 27 South, Range 1 West of the 6th P.M. more fully described as follows:

Beginning at the northwest corner of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of Section 35; thence east 300 feet; thence south to a point 275 feet north of the south line of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of said Section 35; thence west 300 feet to the east line of the west half of the Northeast Quarter of the Northeast Quarter of said Section 35; thence south along said east line to the south line of the Northeast Quarter of the Northeast Quarter of said Section 35; thence west along said south line to the west line of the Northeast Quarter of the Northeast Quarter of said Section 35; thence north along said west line to the north line of the Northeast Quarter of said Section 35; thence east along said north line to the point of beginning, included within the foregoing description being all of Burnham Industrial Addition.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, and 25-983, be and the same are hereby declared to constitute the land within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
