And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-054

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

An unplatted tract in the Southwest Quarter of Section 1, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the northeast corner of the Southwest Quarter of Section 1; thence west along the north line of said Southwest Quarter to a point one thousand eight hundred seventy-nine and one-tenth (1879.1) feet east of the northwest corner of said Southwest Quarter; thence south three hundred (300) feet; thence west along a line

parallel to and three hundred (300) feet south of the north line of said Southwest Quarter a distance of two hundred ninety and four-tenths (290.4) feet; thence westerly three hundred sixty and nine-tenths (360.9) feet to a point two hundred ninety-two and eighty-four hundredths (292.84) feet south of the north line of said Southwest Quarter; thence west four hundred ninety-six and ninety-three hundredths (496.93) feet to the east line of George Washington Boulevard; thence southeasterly along said east line to a point three hundred thirty-six and fifty-eight hundredths (336.58) feet north of the south line of the Northeast Quarter of said Southwest Quarter; thence east to a point on the east line of said Southwest Quarter three hundred thirty-six and fifty-eight hundredths (336.58) feet north of the southeast corner of the Northeast Quarter of said Southwest Quarter; thence north to the point of beginning.
