SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1919 Suppl., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-055

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts and Kansas Turnpike right-of-way in the Northwest Quarter of Section 1, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the intersection of the north line of George Washington Boulevard and the east line of Oliver Street; thence north along the east line of Oliver Street to a point three hundred (300) feet south of the south line of Pawnee Avenue; thence east along a line parallel to and three hundred (300) feet south of the south line of Pawnee Avenue to the south right-of-way line of the Kansas Turnpike; thence southwesterly along said right-of-way line to the north line of George Washington Boulevard; thence northwesterly along said line to the point of beginning.
