ORDINANCE NO. 26-078

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of Montrose Park Addition, more fully described as follows:

Beginning at the northwest corner of Lot 1, Block D, Montrose Park Addition; thence south to the north line of Lot 9, Block L, in said Addition; thence west to the west line of Fairview Avenue; thence south to the south line of 27th Street; thence east to the west line of Park Place; thence north to the south line of 29th Street; thence west to the point of beginning.

SECTION 2.
