ORDINANCE NO. 26-108

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northeast Quarter of Section 28, Township 27 South, Range 2 East of the 6th P.M. and adjacent to U.S. 54 Highway right-of-way and adjacent to Kansas Turnpike right-of-way more fully described as follows:

Beginning at the point of intersection of the west line of said Northeast Quarter extended from the south and the north line of U.S. 54 Highway; thence east along the north line of U.S. 54 Highway to the east line of the Northwest Quarter of said Northeast Quarter extended from the south; thence south to the south line of the Kansas Turnpike; thence west along said south line to the west line of said Northeast Quarter; thence north to point of beginning.

SECTION 2.
