

ORDINANCE NO. 26-115

AN ORDINANCE CREATING A SEWER DISTRICT FOR THE CONSTRUCTION OF A LATERAL SEWER; DEFINING, FIXING AND DETERMINING THE BOUNDARIES OF SAID BENEFIT DISTRICT LIABLE FOR SPECIAL ASSESSMENTS FOR THE COST OF THE CONSTRUCTION OF LATERAL 81, DRY CREEK SUBMAIN NO. 2, SANITARY SEWER NO. 12,

WHEREAS, by resolution dated July 5, 1961, the City Engineer of the City of Wichita was directed to prepare a description of the lands properly coming within the sewer district for the construction of a lateral sewer; and,

WHEREAS, the City Engineer pursuant to such instructions filed a description of such lands in the office of the City Clerk of the City of Wichita, on the 7th day of November, 1961;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That there be and is hereby created a sanitary sewer district which shall be known as Lateral 81, Dry Creek Submain No. 2, Sanitary Sewer No. 12, and that the benefit district liable for special assessments for the cost of construction of such sewer shall be defined, fixed and determined as follows:

Lots 3 through 12, inclusive, Block A, Replat of Lot 7, Block 6, McEwen's 6th Addition.

SECTION 2. That the cost and expense of constructing said Lateral 81, Dry Creek Submain No. 2, Sanitary Sewer No. 12, shall be chargeable to and paid by the owners of the lots and tracts of land as defined in Section 1 hereof, regardless of assessments of any sewer or sewers heretofore levied thereon and each part, piece and parcel of said lands within said district shall be assessed its proper share and portion of the cost of the construction of said Lateral 81, Dry Creek Submain No. 2, Sanitary Sewer No. 12, as above provided and shall be certified by the City Clerk to the County Clerk to be placed upon the tax rolls for collection in the same manner as other taxes.

SECTION 3. That pursuant to law negotiable bonds of the City of Wichita shall be issued to pay the cost of construction of said sewer and the amount thereof shall be chargeable to the benefit district as determined herein and assessed against the specified property located therein, in accordance with law.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 26-116

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the south line of the Northwest Quarter of Section 11 three hundred (300) feet west of the southeast corner of the west half of said Northwest Quarter; thence north one hundred fifty-two (152) feet; thence east to the east line of Clifton Avenue; thence south one hundred fifty-two (152) feet to the south line of said Northwest Quarter; thence west to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, 26-040, 26-041, 26-042, 26-051, 26-052, 26-053, 26-054, 26-055, 26-056, 26-057, 26-058, 26-059, 26-060, 26-061, 26-069, 26-070, 26-073, 26-074, 26-075, 26-076, 26-077, 26-078, 26-079, 26-080, 26-087, 26-088, 26-089, 26-090, 26-091, 26-092, 26-093, 26-094, 26-095, 26-096, 26-106, 26-107, 26-108, 26-109, 26-110, 26-111, 26-112, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:
