

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the south line of the Northwest Quarter of Section 11 three hundred (300) feet west of the southeast corner of the west half of said Northwest Quarter; thence north one hundred fifty-two (152) feet; thence east to the east line of Clifton Avenue; thence south one hundred fifty-two (152) feet to the south line of said Northwest Quarter; thence west to the point of beginning.

SECTION 2. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-117

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN
THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA,
KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract, Atchison, Topeka and Santa Fe Railroad right-of-way and K-42 Highway right-of-way, in the north half of Section 2, Township 28 South, and the Southeast Quarter of Section 35, Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the intersection of the north line of K-42 Highway and the west line of West Street; thence south along said west line to a point five hundred ninety (590) feet south of the intersection of the south line of the Atchison, Topeka and Santa Fe Railroad and the east line of Section 2; thence west eight hundred ninety-one and thirty-seven hundredths (891.37) feet to the southerly right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence south-westerly along said right-of-way line to the east line of the Wichita Valley Center Flood Control Ditch; thence northwesterly to the intersection of the east line of said Ditch and the north right-of-way line of K-42 Highway; thence northeasterly along said north right-of-way line to the point of beginning.
