SECTION 5. The full faith, credit and resources of the City of Wichita, Kansas, shall be, and the same hereby are pledged for the prompt payment of said bonds and all interest thereon as the same mature. The Board of Commissioners of the City of Wichita, Kansas, shall annually make provision for the payment of the principal and interest of said bonds as the same become due, by levying and collecting the necessary taxes therefor in the manner provided by law.

SECTION 6. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 26-127

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita:

Westview Addition in the Southeast Quarter of Section 21, Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the southeast corner of said Southeast Quarter; thence north to the northeast corner of said Southeast Quarter; thence west to the northwest corner of Westview Addition; thence south to the southwest corner of Westview Addition; thence east to point of beginning.

SECTION 2. SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
