And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-135

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

An unplatted tract in the Southwest Quarter of Section 36, Township 26 South, Range 1 East of the 6th P.M., and adjacent street right-of-way, more fully described as follows:

Beginning at the point of intersection of the north line of Ghisholm Park Estates Addition and the west line of Oliver Street; thence north to a point one thousand seven hundred ninety-eight and twenty-five hundredths (1798.25) feet north of the south line of said Southwest Quarter of Section 36; thence east to the east line of the west

half of said Southwest Quarter of Section 36; thence south four hundred ninety-four and twenty-five hundredths (494.25) feet; thence west to the east line of Oliver Street; thence north to a point east of the point of beginning; thence west to the point of beginning.
