ORDINANCE NO. 26-142

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 32, Township 26, South, Range 1, East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the south line of 37th Street and the east line of the northwest quarter of the Northeast Quarter of Section 32; thence south to the southeast corner of the northwest quarter of said Northeast Quarter; thence west along the south line of northwest quarter of said Northeast Quarter to the center line of Chisholm Creek; thence northerly along said center line to the south line of 37th Street; thence easterly along said south line to the point of beginning.

SECTION 2. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-144

AN ORDINANCE VACATING THE NORTH-AND-SOUTH ALLEY BETWEEN WEST STREET AND ILLINOIS AVENUE, AND EMMA AVENUE AND MAPLE STREET, IN BLOCK FOUR (4), QUINCY ADDITION TO THE CITY OF WICHITA, SEDGWICK COUNTY, KANSAS, AND ABANDONING THE SEWER LOCATED IN THE SOUTH 100 FEET THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the North-and-South alley between West Street and Illinois Avenue, and Emma Avenue and Maple Street, in Block Four (4), Quincy Addition to Wichita, Sedgwick County, Kansas, said alley abutting on odd lots 13 through 49, and even lots 14 through 50, in Block 4, in Quincy Addition to the City of Wichita, Kansas, be and the same is hereby vacated.

SECTION 2. That the sewer line located in the south 100 feet thereof be and the same is hereby abandoned.

SECTION 3. It is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that the above described alley be vacated by the said Board in case a proper petition is filed pursuant to G. S. 1949, Section 12-504 to Section 12-506, inclusive.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.
