

ORDINANCE NO. 26-150

AN ORDINANCE INCORPORATING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THE ETC.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas;

Byron Smith Addition and adjacent North Wichita Drainage District right-of-way in the southeast Quarter of Section 32, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of the southwest Quarter of the northwest Quarter of the southeast Quarter of Section 32; thence east to the northwest corner of the southeast Quarter of the northwest Quarter of the southeast Quarter of said Section 32; thence south to the southwest corner of the northwest Quarter of the southwest Quarter of the southeast Quarter of said Section 32; thence west to the southwest corner of the northwest Quarter of the southwest Quarter of the southeast Quarter of said Section 32; thence north to the point of beginning.

SECTION 2. SECTION 3. That if any part of portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
