ORDINANCE NO. 26-256

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 15, Township 27, South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of the Northwest Quarter of Section 15; thence east along the north line of said Northwest Quarter a distance of two hundred (200) feet; thence south parallel to the west line of said Northwest Quarter a distance of two hundred (200) feet; thence west parallel to the north line of said Northwest Quarter to the west line of said Northwest Quarter; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, 26-246, 26-247, 26-248, 26-249, 26-250, 26-255, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

AN ORDINANCE INCORPORATING AND INCORPORATING CERTAIN
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Country Acres 4th "E" Addition, in the Northwest Quarter of Section 15, Township 27, South, Range 1, West of the 6th P.M., more fully described as follows:

Beginning at a point on the north line of the Northwest Quarter of Section 15 one thousand one hundred (1100) feet east of the northwest corner of said Northwest Quarter; thence west along said north line a distance of three hundred eighty-nine and forty-nine hundredths (389.49) feet; thence left eighty-seven (87) degrees seventeen (17) minutes a distance of three hundred fifty (350) feet; thence left ninety (90) degrees a distance of fifty-five (55) feet; thence right sixty-seven (67) degrees twenty-two (22) minutes fifty (50) seconds a distance of one hundred thirty (130) feet; thence right twenty-two (22) degrees thirty-seven (37) minutes ten (10) seconds a distance of four hundred twenty (420) feet; thence right seventy-three (73) degrees forty (40) minutes thirty (30) seconds a distance of four hundred ninety and four-tenths (490.4) feet; thence left seventy-three (73) degrees forty (40) minutes thirty (30) seconds a distance of four hundred ninety-five (495) feet; thence right ninety (90) degrees a distance of one hundred five (105) feet; thence left ninety (90) degrees a distance of one thousand one hundred twenty and sixteen hundredths (1120.16) feet to a point on the south line of said Northwest Quarter; thence left ninety-two (92) degrees eight (8) minutes a distance of eight hundred fifty-nine and thirty-six hundredths (859.36) feet; thence left eighty-seven (87) degrees fifty-two (52) minutes a distance of two thousand six hundred twenty-nine and fifty-three hundredths (2629.53) feet to the point of beginning.
