ORDINANCE NO. 26-549

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

The Original Town of North Wichita, in the Northwest Quarter of Section 33 sixty and twenty-one hundredths (60.21) feet, more or less, east of the northwest corner of said Northwest Quarter, said point being on the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence east along the north line of said Northwest Quarter a distance of one thousand four hundred twenty-four and forty-four hundredths (1424.44) feet; thence south a distance of two thousand five hundred thirty-one and forty-seven hundredths (2531.47) feet, more or less, to a point one hundred fifty (150) feet north of the south line of said Northwest Quarter; thence west parallel to and one hundred fifty (150) feet north of said south line a distance of one thousand four hundred thirty-four and sixteen hundredths (1434.16) feet, more or less, to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence north along said right-of-way line a distance of two thousand five hundred thirty-five and sixteen hundredths (2535.16) feet, more or less, to the point of beginning; except Lots 45, 47 and 49, Block 2, Lots 25, 27, 29, and 31, Block 7, Lots 22, 24, 36, and 39, Block 8, Burton Car Addition.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-217 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
