## ORDINANCE NO. 26-943

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

37th Street right-of-way in the south half of Section 28, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the south line of the Southwest Quarter of Section 28 and the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence north along said right-of-way line a distance of thirty-five (35) feet; thence east parallel to the south line of said Section 28 to the west line of Cleveland Avenue; thence south to the south line of said Section 28; thence west to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

## ORDINANCE NO. 26-944

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Ark Valley Park Addition, in the Northeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 29 five hundred one and six-tenths (501.6) feet north of the southwest corner of said Northeast Quarter; thence north along said west line a distance of six hundred two and thirty-five hundredths (602.35) feet; thence east a distance of four hundred thirty-five and six-tenths (435.6) feet; thence north a distance of one hundred (100) feet; thence east a distance of one thousand two hundred seventy-six and two-tenths (1276.2) feet, more or less, to the west right-of-way line of the Wichita-Valley Center Flood Control-Chisholm Creek Diversion; thence southerly along said right-of-way line a distance of six hundred forty-three and eighty-one hundredths (643.81) feet; thence right at ninety (90) degrees a distance of twenty-five (25) feet; thence southerly along said right-of-way line a distance of sixty-six and seventy-four hundredths (66.74) feet to a point five hundred one and six-tenths (501.6) feet north of the south line of said Northeast Quarter; thence west a distance of one thousand five hundred ninety-eight and six-tenths (1598.6) feet, more or less, to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
