

ORDINANCE NO. 26-952

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the west half of Section 22, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of the Southwest Quarter of Section 22; thence south along the west line of said Southwest Quarter a distance of one hundred sixty-four and eight-tenths (164.8) feet, more or less, to a point two thousand four hundred eighty-one and twenty-nine hundredths (2481.29) feet north of the southwest corner of said Southwest Quarter; thence left at an angle of eighty-nine (89) degrees forty-six (46) minutes a distance of two hundred ninety-three and one-tenth (293.1) feet; thence left at an angle of ninety (90) degrees fourteen (14) minutes a distance of eighty-six and fifteen hundredths (86.15) feet to the point of curvature of a curve to the right having a delta of forty-five (45) degrees zero (0) minutes thirty (30) seconds and a radius of one hundred ten (110) feet; thence along said curve a distance of eighty-six and four-tenths (86.4) feet, more or less, to a point on the north line of said Southwest Quarter three hundred twenty-five and eighty-six hundredths (325.86) feet east of the northwest corner of said Southwest Quarter; thence east along said north line a distance of six hundred twenty-six and twenty-seven hundredths (626.27) feet; thence left at ninety (90) degrees a distance of four hundred eighty-six and twenty-six hundredths (486.26) feet; thence left at ninety (90) degrees a distance of six hundred fifty-seven and seven hundredths (657.07) feet; thence right at ninety (90) degrees a distance of two hundred sixty-five (265) feet; thence left at ninety (90) degrees a distance of two hundred ninety-four and seventy-eight hundredths (294.78) feet to the west line of the Northwest Quarter of Section 22; thence south a distance of seven hundred fifty-one and twenty-six hundredths (751.26) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney, be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 18-217 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-953

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Southwest Quarter of Section 22, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the Southwest Quarter of Section 22; thence north along the west line of said Southwest Quarter a distance of one thousand seven hundred fifty-five and eighty-two hundredths (1755.82) feet; thence right at an angle of ninety (90) degrees nine (9) minutes a distance of two hundred ninety and six hundredths (290.06) feet; thence left at an angle of ninety (90) degrees nine (9) minutes a distance of one hundred fifty (150) feet; thence left at an angle of eighty-nine (89) degrees fifty-one (51) minutes a distance of two hundred ninety-one and thirty-five hundredths (291.35) feet to the west line of said Southwest Quarter; thence south a distance of one thousand nine hundred five and eighty-two hundredths (1905.82) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
