

Beginning at a point on the north line of the Southeast Quarter of Section 20 four hundred fifty-three and fifty-five hundredths (453.55) feet west of the northeast corner of said Southeast Quarter; thence south a distance of one thousand one hundred sixty-six and thirty-three hundredths (1166.33) feet, more or less, to a point four hundred fifty-three and five-tenths (453.5) feet west and one thousand four hundred eighty-eight and five-tenths (1488.5) feet north of the southeast corner of said Southeast Quarter; thence west parallel to the south line of said Southeast Quarter a distance of four hundred eighty-three and five-tenths (483.5) feet; thence south parallel to the east line of said Southeast Quarter a distance of one hundred twenty-eight and five-tenths (128.5) feet to the north line of Douglas Avenue; thence west along said north line to a point one hundred thirty-five (135) feet east of the west line of the east half of the west half of said Southeast Quarter; thence north parallel to said west line to the north line of said Southeast Quarter; thence east to the point of beginning.

SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
