ORDINANCE NO. 27-031

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Pippin Second Addition, in the Southeast Quarter of Section 19, Township 28 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at the northeast corner of the Southeast Quarter of Section 19; thence south along the east line of said Southeast Quarter a distance of six hundred nineteen and ninety-eight hundredths (619.98) feet; thence west parallel to the north line of said Southeast Quarter a distance of six hundred forty (640) feet; thence south parallel to the east line of said Southeast Quarter a distance of one hundred sixty-six and sixty-six hundredths (166.66) feet; thence west parallel to the north line of said Southeast Quarter a distance of nine hundred sixty (960) feet; thence north parallel to the east line of said Southeast Quarter a distance of seven hundred eighty-six and sixty-four hundredths (786.64) feet to the north line of said Southeast Quarter; thence east a distance of one thousand six hundred (1600) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, 27-011, 27-012, 27-013, 27-014, 27-015, 27-030, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
