SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

ORDINANCE NO. 27-132

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 29, Township 26 South Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 29 one thousand four hundred seventy-two and sixty-four hundredths (1472.64) feet north of the southwest corner of said Northeast Quarter; thence north along said west line a distance of three hundred ninety (390) feet; thence east parallel to the south line of said

Northeast Quarter a distance of seven hundred twenty-six (726) feet; thence south parallel to the west line of said Northeast Quarter a distance of two hundred forty (240) feet to the north line of J. B. Muller Addition; thence west along said north line a distance of one hundred fifty-one (151) feet; thence south parallel to the west line of said Northeast Quarter a distance of one hundred fifty (150) feet; thence west a distance of five hundred seventy-five (575) feet to the point of beginning.

ORDINANCE NO. 27-133

AN ORDINANCE ADDING CERTAIN PARCELS, PIECES AND TRACTS OF LAND TO INDUSTRIAL DISTRICT NO. 1; SETTING FORTH THE DESCRIPTION OF SUCH ADDITIONAL PARCELS, PIECES AND TRACTS OF LAND AND SPECIFYING THE TAXES TO BE IMPOSED THEREON.

WHEREAS, Chapter 14.08 of the Code of the City of Wichita provides for the creation of industrial districts setting forth the purposes thereof, the requirements and criteria, the taxes imposed upon an industrial district, the procedure of formation, the manner of additions thereto and termination thereof; and

WHEREAS, the Board of Commissioners of the City of Wichita have adopted Ordinance No. 26-893 creating Industrial District No. 1; and

WHEREAS, requests have been received providing for an addition to Industrial District No. 1 as provided in Chapter 14.08, Code of the City of Wichita, Kansas; and

WHEREAS, such request was signed by 69.35% of the area proposed to be added to Industrial District No. 1; and
