ORDINANCE NO. 27-154

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southeast corner of the northeast quarter of the Northwest Quarter of Section 11; thence north along the east line of said Northwest Quarter to a point six hundred sixty-four (664) feet south of the north line of said Northwest Quarter; thence west parallel to said north line to the east line of Clifton Avenue; thence south along said east line to the south line of the northeast quarter of said Northwest Quarter; thence east to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, 27-011, 27-012, 27-013, 27-014, 27-015, 27-030, 27-031, 27-032, 27-033, 27-041, 27-042, 27-043, 27-131, 27-132, 27-139, 27-140, 27-141, 27-153, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
