

Wichita Drainage Canal approximately sixty (60) feet North of the center of Section 3, Township 28 South, Range 1 East of the 6th P.M.; thence Northwesterly along the Wichita Drainage Canal to a point approximately two hundred seventy (270) feet North of the North line of Stafford Street, the real property described in Section 1 hereof.

SECTION 3. That the City Attorney be and he is hereby directed, authorized and instructed to make proper application to a Judge of the District Court of Sedgwick County, Kansas, for the appropriation of said lands, praying for the condemnation thereof, and the appointment of commissioners to assess, determine and fix the damages resulting from such condemnation and to take such other proceedings as may be required by law.

SECTION 4. That the cost of said improvements when ascertained shall be paid in accordance with Agreement 51-58 dated the 9th day of December 1958 by and between the City of Wichita, Kansas, and the State Highway Commission of Kansas and the Supplemental No. 1 to Agreement 53-58 per Ordinance No. 27-350 adopted September 10, 1963, when the same shall be ascertained in the proceedings to be instituted and maintained in the District Court of Sedgwick County, Kansas; provided that the City of Wichita, Kansas, on completion of said proceedings shall elect to acquire said property (and the City of Wichita hereby reserves the right to either reject or acquire said property when and after the value and cost thereof shall be determined).

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-461

AN ORDINANCE DECLARING, ESTABLISHING AND DEFINING THE CITY LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AFTER ALL ANNEXATIONS OF TERRITORY, AND EXCLUSIONS OF TERRITORY SINCE JANUARY 1, 1963.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That hereafter and until altered or changed in accordance with the law, the city limits are, and the entire boundaries of the City of Wichita, Kansas, are hereby defined, established and declared to be as follows:

Beginning at the center of Section 18, Township 27 South, Range 2 East of the 6th P.M., being the Southeast Corner of First Addition to Pine Valley Estates; thence north along the east line of the Northwest Quarter of said Section 18 and the east line of the Southwest Quarter of Section 7, Township 27, South, Range 2 East of the 6th P.M. to the south line of the St. Louis and San Francisco Railroad right-of-way; thence west along said right-of-way line to the east line of Government Lot 1 in the Northwest Quarter of said Section 7, extended from the north; thence north along said east line to the north line of said Government Lot 1; thence west along said north line to the east line of Westlaw Boulevard; thence north along said east line to the north line of Third Addition to Crestview Heights, extended from the west; thence west along the north line of said Addition to the west line of said Addition; thence north along the west line of said Addition to the north line of 11th Street; thence west along the north line of

21st Street to the east line of the Southwest Quarter of Section 1, Township 27 South, Range 1 East of the 6th P. M. to the east line of the west half of said Northeast Quarter; thence north along said east line to the north line of said Section 33; thence west along said north line to the west line of Cleveland Avenue extended from the north; thence north to the north line of 37th Street; thence west along said north line to the east right-of-way line of the St. Louis-San Francisco Railroad; thence north along said right-of-way line to the southerly right-of-way line of the Chisholm Creek Diversion; thence southwesterly along said right-of-way line to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence north along said right-of-way line to the north line of the southeast quarter of the Southeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th P. M. extended from the west; thence west along said north line to the east right-of-way line of U. S. M.; thence west along said north line to the east line of Reserve "A", Gifford Addition; thence southwesterly and northwesterly along the southerly line of said Reserve "A" to the north line of said Northeast Quarter; thence west along said north line to the west line of the Northeast Quarter of said Northeast Quarter; thence south along said west line to a point ninety and six-tenths (90.6) feet north of the south line of the Northeast Quarter of said Northeast Quarter; thence west a distance of three hundred thirty-four and one-tenth (334.1) feet; thence south a distance of one thousand four hundred nineteen (1419) feet to the south line of said Northeast Quarter one thousand six hundred fifty (1650) feet west of the southeast corner of said Northeast Quarter; thence west along said south line to the west line of the Southeast Quarter of said Section 30; thence south along said west line to the northerly right-of-way line of Interstate Highway 235; thence westerly and southerly along said right-of-way line to the south line of the Southeast Quarter of Section 21, Township 26 South, Range 1 West of the 6th P. M.; thence west along said south line to the west right-of-way line of Interstate Highway 235; thence southerly along said right-of-way line to the north line of the Southwest Quarter of Section 1, Township 27 South, Range 1 West of the 6th P. M.; thence southwesterly to the point of intersection of the west line of the Flood Control Right-of-Way along the right bank of the Big Arkansas River and the east right-of-way of the Flood Control Ditch; thence southwesterly and southeasterly along the east right-of-way of the Flood Control Project to the west line of Hoover Street as platted in Section 22, Township 26 South, Range 1 West; thence south along the west line of Hoover Street to the north line of Section 27, Township 27 South, Range 1 West of the 6th P. SECTION 2. That the following blocks, parcels, pieces and tracts of land be and they are hereby excluded from the corporate limits of the City of Wichita, even though completely surrounded by the territory of the City of Wichita and nothing herein shall otherwise be construed as incorporating or including such blocks, parcels, pieces and tracts of land within the city limits, such lands being described as follows:

(a) Beginning at the intersection of the north line of Kellogg Street and the west line of Woodlawn Boulevard; thence north along said west line to the center line of Douglas Avenue; thence west along said center line to the west line of Woodlawn Heights Addition; thence north along said west line a distance of 655 feet; thence east 377 feet; thence north 665 feet more or less, to the north line of the South half of the Northeast Quarter of Section 24, Township 27 South, Range 1 East of the 6th P. M.; thence east along said north line and the south line of Cresthill Manor Addition to the east line of the West half of Section 19, Township 27 South, Range 2 East of the 6th P. M.; thence south along said east line to the south line of Block U, Eastborough 3rd Addition; thence west to the east line Block DZ, in said Addition, extended from the south; thence south along said east line and the east line of Block EZ, in said Addition to the north line of Kellogg Street; thence west to the point of beginning.

SECTION 3. That the territory embraced within the limits and boundaries described in Section 1 hereof is the territory included within Section 1 of Ordinance No. 26-918 effective December 31, 1962, as amended by Ordinance No. 26-932, effective January 17, 1963, plus the territory specified and described in Section 1 of Ordinances No'd 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, 26-935, 26-936, 26-937, 26-943, 26-944, 26-945, 26-950, 26-951, 26-952, 26-953, 26-954, 26-955, 26-958, 26-959, 26-960, 26-961, 26-962, 26-973, 26-974, 26-975, 26-976, 26-992, 26-993, 26-994, 27-011, 27-012, 27-013, 27-014, 27-015, 27-030, 27-031, 27-032, 27-033, 27-041, 27-042, 27-043, 27-131, 27-132, 27-139, 27-140, 27-141, 27-153, 27-154, 27-155, 27-187, 27-199, 27-200, 27-433, 27-441, 27-447, 27-448, 27-449, 27-450.

SECTION 4. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those theretofore established by law.

SECTION 5. That Section 1 of Ordinance No. 26-918 and all other ordinances and parts of ordinances inconsistent with or in conflict with the terms and provisions hereof be and the same are hereby repealed.

SECTION 6. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
