ORDINANCE NO. 28-634

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Eastlink Village and unplatted tracts in the Southwest Quarter of Section 30, Township 27, South, Range 2, East of the 6th P. M., and adjacent Woodlawn Boulevard right-of-way, more fully described as follows:

Beginning at the southeast corner of the Southwest Quarter of Section 30, Township 27, South, Range 2, East of the 6th P. M.; thence north along the east line of said Southwest Quarter to the south line of Eastridge 7th Addition; thence west along said south line and said line extended to the west line of Woodlawn Boulevard; thence south along said west line to the south line of said Southwest Quarter extended from the east; thence east to the point of beginning.

SECTION 2. That the land specified and included in Section 1 of this ordinance, together with the land specified and included within Section 1 of Ordinance Nos. 28-432, 28-453, 28-460, 28-471, 28-485, 28-486, 28-489, 28-514, 28-515, and 28-516, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any term or provision hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance reciting the boundaries and limits of the City of Wichita, Kansas, under and subject to F.R.A. 1-100, et seq.

SECTION 5. That said ordinance shall take effect and be in force from and after its passage and publication according to the official city papers.

ORDINANCE NO. 28-635

AN ORDINANCE VACATING THE ALLEY BETWEEN LOTS 97 AND 99, ON LAURA AVENUE, IN SUPPLEMENTAL PLAT OF COCHRAN'S SUBDIVISION IN LOTS 5 AND 6, BLOCK A, AND LOTS 1 AND 10, BLOCK B, IN HUNTER'S ADDITION TO THE CITY OF WICHITA, SEDGWICK COUNTY, KANSAS.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF WICHITA, SEDGWICK COUNTY, KANSAS:

SECTION 1. That the alley described as follows, to-wit:

The east-west alley, 20 feet wide and 140 feet in length, lying between Lot 97 on the north and Lot 99 on the South, on Laura Avenue in Supplemental Plat of Cochran's Subdivision in Lots 5 and 6, Block A, and Lots 1 and 10, Block B, in Hunter's Addition to the City of Wichita, Sedgwick County, Kansas,

be and the same is hereby vacated and title thereto relinquished to the abutting property in equal proportions.

SECTION 2. That it is hereby recommended to the Board of County Commissioners of Sedgwick County, Kansas, that said above described land be vacated by said Board in case a proper petition is filed under the provisions of Kansas Statutes Annotated, 12-504, 12-505, and 12-506.

SECTION 3. This ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.
