ORDINANCE NO. 32-540

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of Sections 5 and 6, Township 27 South, Range 2 East of the 6th P. M., and part of Sections 31 and 32, Township 26 South, Range 2 East of the 6th P. M., Sedgwick County, Kansas, more fully described as follows:

Beginning at the northwest corner Section 6, Township 27 South, Range 2 East of the 6th P. M.; thence south along the west line of said Section 6 to the northwest corner of the Southwest Quarter of the Northwest Quarter of said Section 6; thence east along the north line of said Southwest Quarter to the northeast corner of Hinkle's Addition; thence south along the east line of said Addition to the south line of the Northwest Quarter of said Section 6; thence east along the south line of said Northwest Quarter to the northwest corner of the Southeast Quarter of said Section 6; thence south along the west line of said Southeast Quarter to the north line of 21st Street; thence east along said north line to a point one thousand (1,000) feet west of the east line of said Southeast Quarter; thence northerly parallel with said east line to the south line of the Northeast Quarter of said Southeast Quarter; thence westerly along said south line to the west line of the Northeast Quarter of said Southeast Quarter; thence north along said west line and the west line of the Southeast Quarter of the Northeast Quarter of said Section 6 to the north line of the Southeast Quarter of said Northeast Quarter; thence easterly along said north line and along the north line of the Southwest Quarter of the Northwest Quarter of Section 5, Township 27 South, Range 2 East of the 6th P. M. to a point one thousand (1,000) feet east of the west line of said Section 5; thence northerly parallel with said west line to the south line of 29th Street; thence westerly along said south line to the west line of Rock Road; thence northerly along said west line to a point one thousand two hundred twenty (1,220) feet south of the north line of the Northeast Quarter of Section 31, Township 26 South, Range 2 East of the 6th P. M.; thence easterly parallel to said north line and the north line of Northwest Quarter, Section 32, Township 26 South, Range 2 East of the 6th P. M. to a point sixty (60) feet east of the west line of said Northwest Quarter; thence northerly parallel to said west line to a point one thousand one hundred twenty (1,120) feet south of the north line of said Northwest Quarter; thence westerly

parallel to said north line and the north line of the Northeast Quarter, Section 31, Township 26 South, Range 2 East of the 6th P. M., to a point twenty (20) feet west of the west line of Rock Road; thence south parallel to the east line of said Section 31 to a point two thousand (2,000) feet north of the south line of said Section 31; thence west parallel with said south line to the west line of the Southeast Quarter of said Section 31; thence south along said west line to a point one thousand six hundred (1,600) feet north of the south line of said Section 31; thence west parallel with said south line to the east line of Woodlawn Boulevard; thence south along said east line to the south line of said Section 31; thence west to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 32-466, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.


SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.


