AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of the Northeast Quarter, Section 9, Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning fifty (50) feet west of the Southeast Corner of the Northeast Quarter of Section 9, Township 27 South, Range 1 West of the 6th P.M.; thence north parallel to and fifty (50) feet west of the east line of said Northeast Quarter a distance of three hundred fifty-one and seventy-two hundredths (351.72) feet; thence bearing south eighty-nine (89) degrees twenty (20) minutes west a distance of two hundred (200) feet; thence north parallel to the east line of said Northeast Quarter to the southerly line of Block C, Westwood Heights First Addition; thence westerly along the southerly line of said Block C a distance of four hundred forty and sixty-one hundredths (440.61) feet; thence northwesterly along the westerly line of said addition to the northwesterly most corner of Lot 1, Block D in said addition; thence northeasterly along the northerly line of Lot 1, Block D, and the northerly line of Lots 4 and 5, Block A in said addition to the southwesterly corner of Lot 3, Block A in said addition; thence northerly along the west line of Lot 3, Block A in said addition to the north line of the South Half of the Northeast Quarter, Section 9, Township 27 South, Range 1 West; thence west along the north line of the South Half of said Northeast Quarter to a point six hundred seven and five tenths (607.5) feet east of the Northwest Corner of the South Half of said Northeast Quarter; thence south parallel with the west line of said Northeast Quarter to the south line of said Northeast Quarter; thence east along the south line of said Northeast Quarter to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 34-768, 34-820, 34-850, 35-000, 35-025 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.


SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.


