

ORDINANCE NO. 36-609

*Let's proceed

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Northwest Quarter of Section 7, Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the Southeast Corner of the Northwest Quarter of Section 7, Township 27 South, Range 1 West of the 6th P.M.; thence North along the east line of said Northwest Quarter to the south line of the North Half of said Northwest Quarter; thence West along said south line for a distance of four hundred ninety-five (495) feet; thence North parallel to the east line of said Northwest Quarter to a point lying sixty (60) feet South and four hundred ninety-five (495) feet West of the Northeast Corner of said Northwest Quarter; thence West along a line lying parallel to and sixty (60) feet South of the north line of said Northwest Quarter to a point lying sixty (60) feet South and thirty (30) feet East of the Northwest Corner of said Northwest Quarter; thence South along a line lying parallel to and thirty (30) feet East of the west line of said Northwest Quarter to the south line of said Northwest Quarter; thence East along said south line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 36-392, 36-399, 36-424, 36-425, 36-437, 36-438, 36-579, 36-580, 36-581, 36-582, & 36-597 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul

any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.


