AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Tracts of land in Sections 17 and 18, Township 27 South, Range 1 West of the 6th P.M. in Sedgwick County, Kansas, more fully described as follows:

Beginning at a point forty (40) feet West of and thirty (30) feet South of the Northwest Corner of Section 17, Township 27 South, Range 1 West of the 6th P.M.; thence South parallel to and forty (40) feet West of the West line of said Section 17 to a point one hundred thirteen and ninety hundredths (113.90) feet South and forty (40) feet West of the Northwest Corner of the South Half of the Northwest Quarter of said Section 17; thence East parallel to the North Line of said Section 17 to a point fifty (50) feet East of the West Line of said Section 17; thence North parallel to and fifty (50) feet East of said West Line to a point thirty (30) feet South of the North Line of said Section 17; thence West to the point of beginning.

Also beginning at a point forty (40) feet West and four hundred eighty-six and ninety hundredths (486.90) feet South of the Northwest Corner of the South Half of the Northwest Quarter of Section 17, Township 27 South, Range 1 West of the 6th P.M.; thence South parallel to and forty (40) feet West of the West Line of said Section 17 to a point four hundred sixty-two (462) feet North of the extended South Line of the North Half of the Southwest Quarter of said Section 17; thence East parallel to said extended South Line to a point fifty (50) feet East of the West Line of said Section 17; thence North parallel to and fifty (50) feet East of said West Line to a point four hundred eighty-six and ninety hundredths (486.90) feet South and fifty (50) feet East of the Northwest Corner of the South Half of the Northwest Quarter of Section 17, Township 27 South, Range 1 West of the 6th P.M.; thence West to the place of beginning.

Also beginning at the intersection of the North Line of Toh-N-Hah Village with the West Line of

the Southwest Quarter of Section 17, Township 27 South, Range 1 West of the 6th P.M.; thence West along the extended North Line of Toh-N-Hah Village for a distance of forty (40) feet; thence South parallel to and forty (40) feet West of said West Line to the North Line of Central Avenue; thence East along said North Line to the West Line of said Southwest Quarter; thence North along said West Line to the point of beginning.


SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 37-615, ~~437-640~~ be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.


SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
