

ORDINANCE NO. 38-123

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in Sections 20, 29 and 30, Township 26 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the intersection of the South Line of Government Lot 2 in Section 29, Township 26 South, Range 2 East of the 6th P.M. with the East Line of the Northwest Quarter of said Section 29; thence West along said South Line to the Southerly Right-of-Way Line of the Missouri Pacific Railroad; thence Southwesterly along said Right-of-Way Line to the West Line of Rock Road; thence North along said West Line to the South Line extended West of Government Lot 2 in said Section 29; thence East along said extended South Line to a line lying parallel to and one hundred eighty-one and five tenths (181.5) feet East of the West Line of said Northwest Quarter; thence North along said line to the North Line of 45th Street North; thence East along said North Line to the East Line extended North of the Northwest Quarter of Section 29, Township 26 South, Range 2 East of the 6th P.M.; thence South along said extended line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 37-615, 37-640, 37-641, 37-642, 37-643, 37-686, 37-687, 37-877, 37-878, 37-908, 38-011, 38-012, 38-013, 38-014, 38-071, 38-072, 38-078, 38-079, 38-080, 38-081, 38-095


be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.


