ORDINANCE NO. 40-040

OCT 7 1987

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in Section 24, Township 28 South, Range 1 West, and Section 19, Township 28 South, Range 1 East of the 6th P.M., Sedgwick County, Kansas, described as:

Beginning at the intersection of the west line of Meridian and the north line of Section 24, Township 28 South, Range 1 West; thence south along said west line to the south line of 47th Street South; thence west along said south line to the west line of the east half of the Northeast Quarter of said Section 24; thence south along said west line to the south line of said Northeast Quarter; thence S 89°58'42" W along said south line 345 feet; thence S 45°04'59" E for a distance of 417.57 feet; thence S 13°51'16" E for a distance of 211.17 feet to a point on the west line of the Northeast Quarter of the Southeast Quarter of said Section 24; thence south along said west line to the south line of said Northeast Quarter of said Southeast Quarter; thence east along said south line to the west line of Meridian; thence north along said west line to the south line of 47th Street South;

thence east along said south line to the west line of the east half of Section 19, Township 28 South, Range 1 East; thence north along said west line to the north line of said Section 19; thence west along said north line and said line extended to the point of beginning.


SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 39-728, 39-741, 39-764, 39-838, 39-839, 39-840, 39-852, 39-872, 39-873, 39-874, 39-877, 39-895, 39-898, 39-899, 39-903, 39-913, 39-918, 39-967, 39-968, 39-969, 40-017, & 40-034 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.


SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
