ORDINANCE NO. 26-076

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southwest Quarter of Section 1 and in the north half of Section 12, Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the intersection of the easterly Flood Control right-of-way on the left bank of the Big Arkansas River and the south line of Bluebird Drive extended from the east; thence southerly and easterly along said right-of-way to the south line of 21st Street; thence east along said south line to the east line of Benjamin Hills Estates Addition extended from the north; thence south to the intersection of the right bank of the Big Arkansas River and the west line of St. Paul Avenue; thence northwesterly along the meanderings of said right bank to the west line of Sheridan Avenue; thence northwesterly to the intersection of the north line of McLean Boulevard and the east line of Sunset Heights 5th Addition; thence north to the north line of 21st Street; thence west to the west line of the Flood Control right-of-way along the right bank of the Big Arkansas River; thence northwesterly along said right-of-way to the east right-of-way line of the Flood Control Ditch; thence northeasterly to the point of intersection of the west right-of-way line of Interstate Highway 235 and the north line of the Southwest Quarter of Section 1, Township 27 South, Range 1 West of the 6th P.M.; thence east along said north line to the easterly Flood Control right-of-way; thence southerly along said right-of-way to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, 26-040, 26-041, 26-042, 26-051, 26-052, 26-053, 26-054, 26-055, 26-056, 26-057, 26-058, 26-059, 26-060, 26-061, 26-069, 26-070, 26-073, 26-074, 26-075, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-077

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 5, Township 27 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the west line of Fairview Avenue and the south line of the North half of the Northeast Quarter of Section 5, Township 27 South, Range 1 East of the 6th P.M.; thence west to the east line of North Court Addition; thence north to the north line of North Court Addition; thence west to the west line of Arkansas Avenue; thence north three hundred seven and five-tenths (307.5) feet; thence east to a point on the center line of old Chisholm Creek seven hundred fifty-eight and eight-tenths (758.8) feet south of the north line of said Northeast Quarter; thence southerly and easterly following the meanderings of the center line of old Chisholm Creek to the west line of Fairview Avenue; thence south to point of beginning.

SECTION 2.
