ORDINANCE NO. 26-094

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in the southwest Quarter of Section 1, Township 28 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at a point on the north line of said southwest Quarter one thousand eight hundred seventy-nine and one-tenth (1879.1) feet east of the northwest corner of said southwest Quarter; thence south three hundred (300) feet; thence west along a line parallel to and three hundred (300) feet south of the north line of said southwest Quarter a distance of two hundred ninety and four tenths (290.4) feet; thence westerly three hundred sixty and nine tenths (360.9) feet to a point two hundred ninety-two and eighty-four hundredths (292.84) feet south of the north line of said southwest Quarter; thence west four hundred ninety-six and ninety-three hundredths (496.93) feet to the east line of George Washington Boulevard; thence northwesterly to the north line of said southwest Quarter; thence east to point of beginning.

SECTION 2. SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 e' seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
