ORDINANCE NO. 26-106

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Mileen Acres Addition and unplatted tracts in the Northwest Quarter of Section 5, Township 27 South, Range 1 East of the 6th P.M. and adjacent 29th Street right-of-way, more fully described as follows:

Beginning at the point of intersection of the west line of said northwest Quarter extended from the south and the north line of 29th Street; thence east along the north line of 29th Street to the east line of Block A, Mileen Acres Addition extended from the south; thence south to the southeast corner of said Addition; thence west to the west line of said Northwest Quarter; thence north to point of beginning.

SECTION 2.
