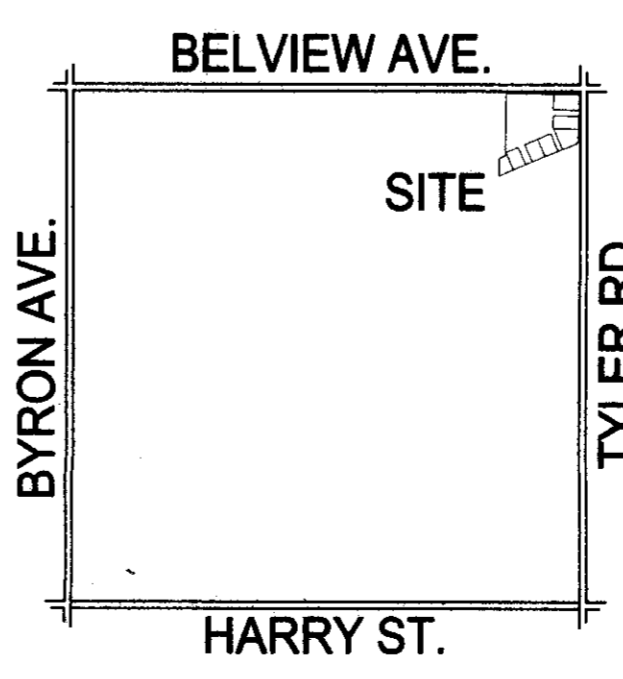
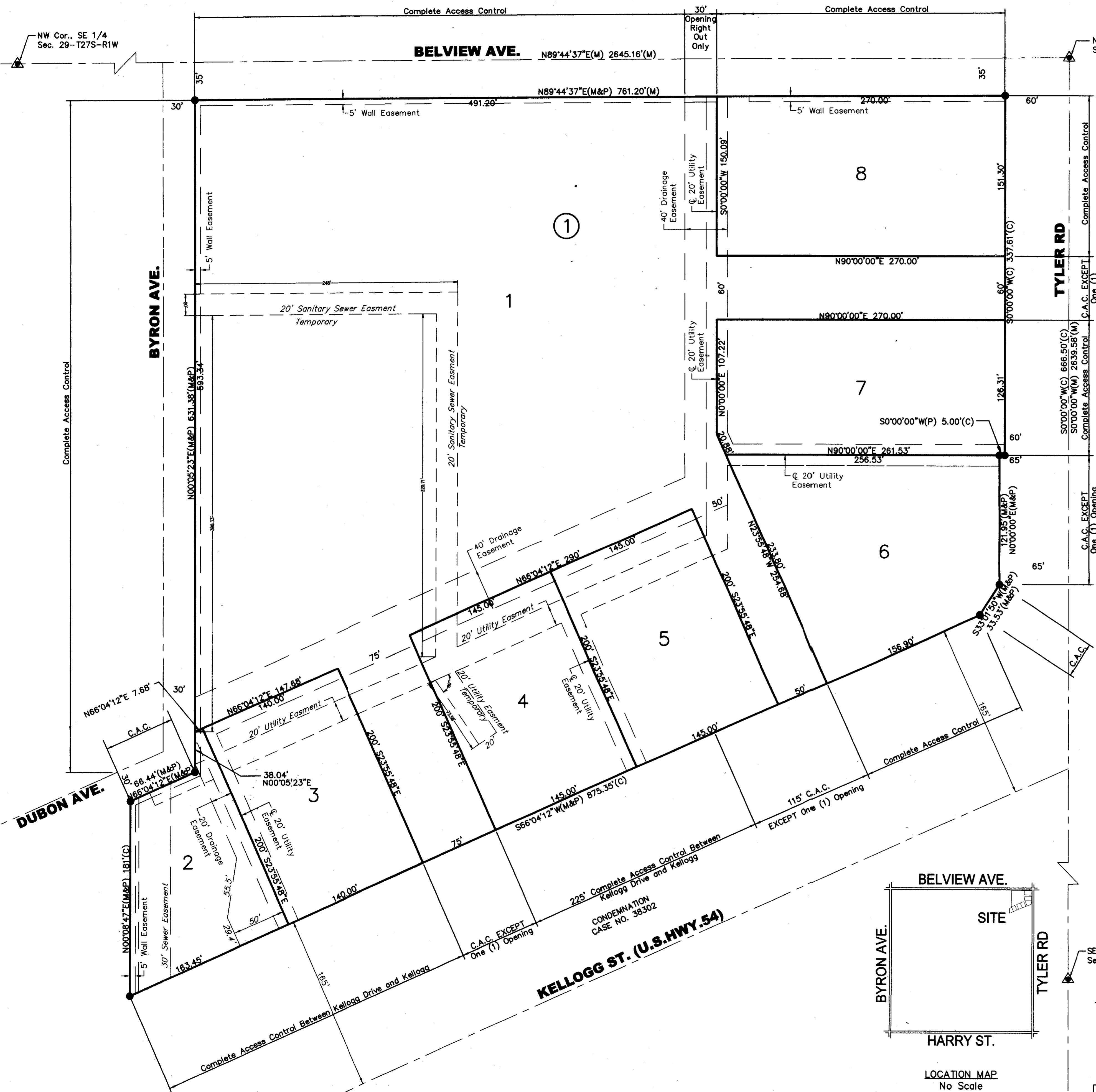
FINAL PLAT of HOLLAND COMMERCIAL ADDITION WICHITA SEDGWICK COUNTY KANSAS
