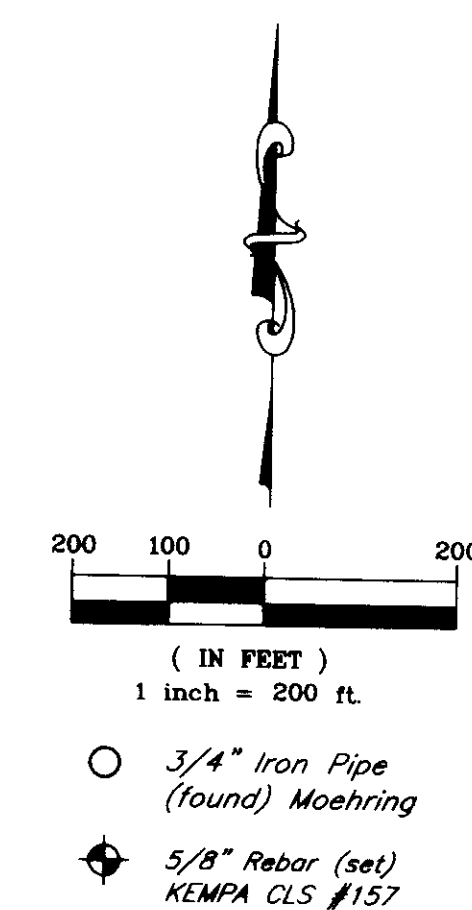
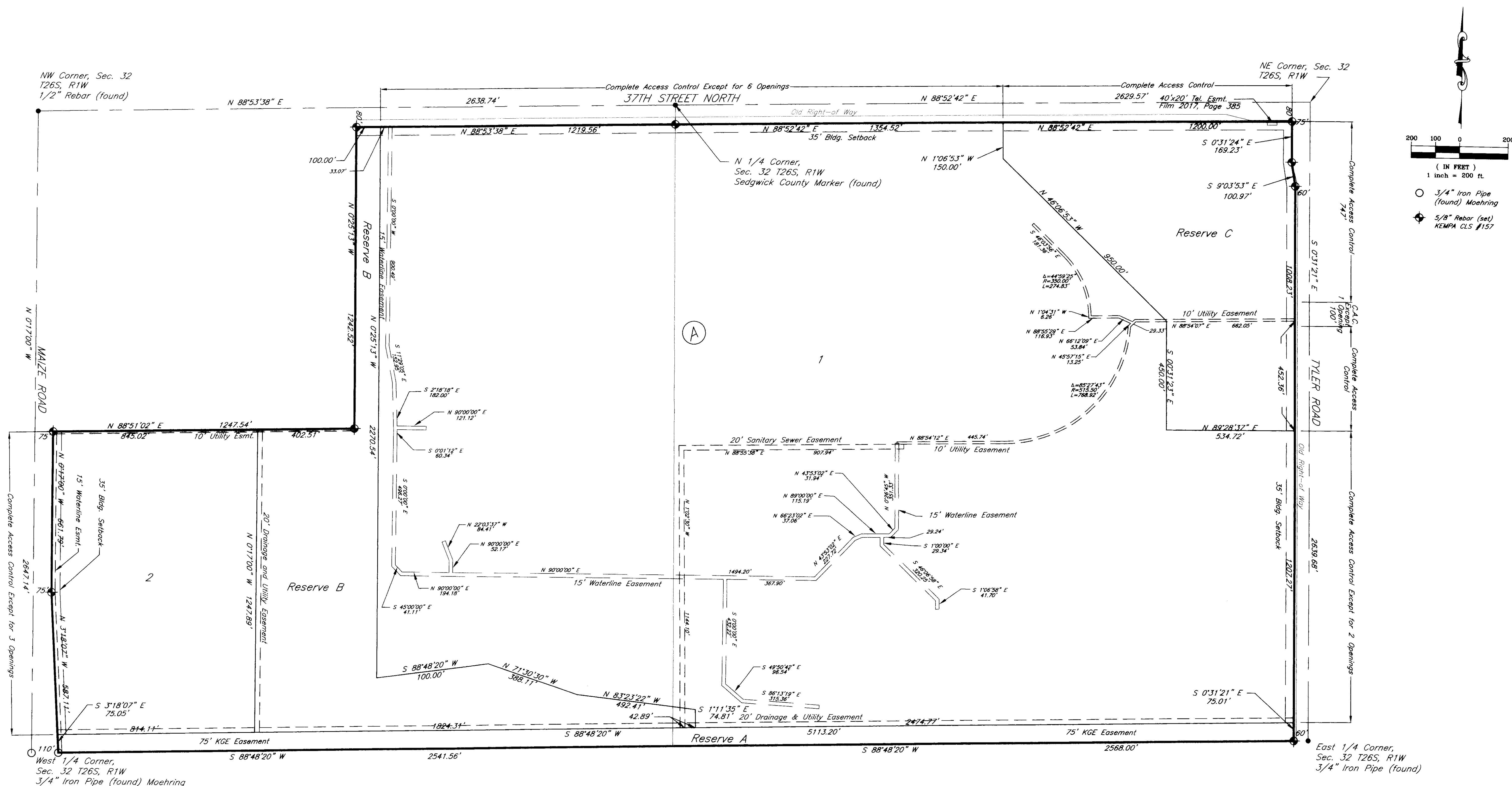

Legal Description

The Northeast Quarter of the Northwest Quarter of Section 32, Township 26 South, Range 1 West, of the Sixth Principal Meridian, Sedgwick County, Kansas.

The South Half of the Northwest Quarter of Section 32, Township 26 South, Range 1 West, of the Sixth Principal Meridian, Sedgwick County, Kansas.

The Northeast Quarter of Section 32, Township 26 South, Range 1 West, of the Sixth Principal Meridian, Sedgwick County, Kansas, EXCEPT that part platted as Central Maize Schools Addition, Wichita, Sedgwick County, Kansas.

Lot 1, Block A, Central Maize Schools Addition, Wichita, Sedgwick County, Kansas.

All being situated in the North half of Section 32, Township 26 South, Range 1 West, of the Sixth Principal Meridian, Sedgwick County, Kansas.

Said tract contains 266.48 acres ±.

All easements and rights-of-way within said lots are hereby vacated by virtue of KSA 12-512(b) amended.

Know all men by these presents, that we, the undersigned, have caused the land described in the surveyor's certificate to be platted into Lots and Blocks and Reserves to be known as Maize School South Campus Addition, Wichita, Sedgwick County, Kansas. Any easements are hereby granted as indicated for constructing, maintaining, operating, and repairing public utilities. A drainage plan has been developed for the plat and all drainage easements, rights-of-way, or reserves shall remain at established grades or as modified with the approval of the applicable City or County Engineer, and unobstructed to allow for the conveyance of stormwater. Reserve A shall be owned and maintained by the Fox Ridge Homeowners Association for use as a storm water pond and or pedestrian access and landscaping. Reserves B and C shall be owned and maintained by Maize USD 266 and used for storm water detention, pedestrian access, access drives, landscaping, playgrounds, vehicular parking, and athletic fields. Failure to maintain reserves will result in the City maintaining the reserves and charging the responsible parties for all related costs. And further that the land contained herein is held and shall be conveyed subject to any applicable restrictions, reservations and covenants now on file or hereafter filed in the Office of the Register of Deeds of Sedgwick County, Kansas. ~~Streets shall be dedicated to and for the use of the public.~~

Access Control is hereby granted as follows:

1. There shall be a maximum of 3 openings on Maize and Tyler Roads, and 6 openings on 37th Street North, per City of Wichita Access Management Standards.

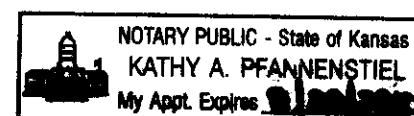

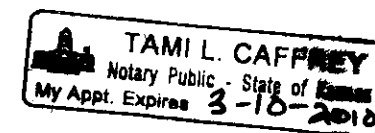

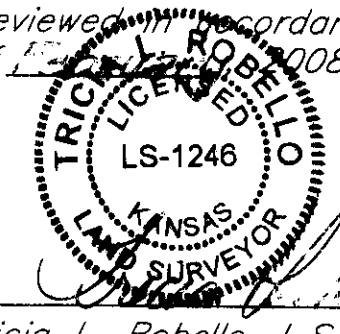
