

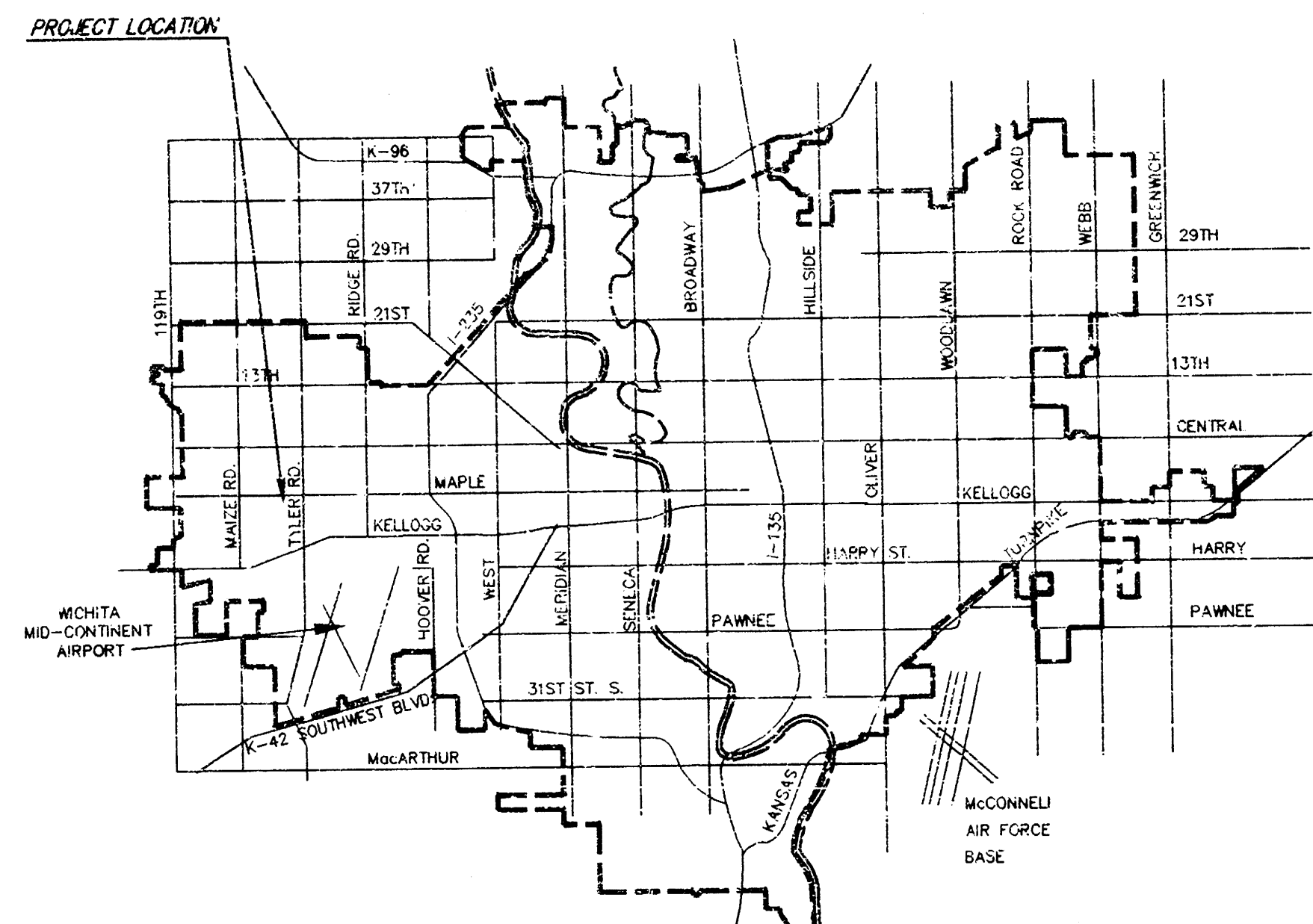

GENERAL NOTES

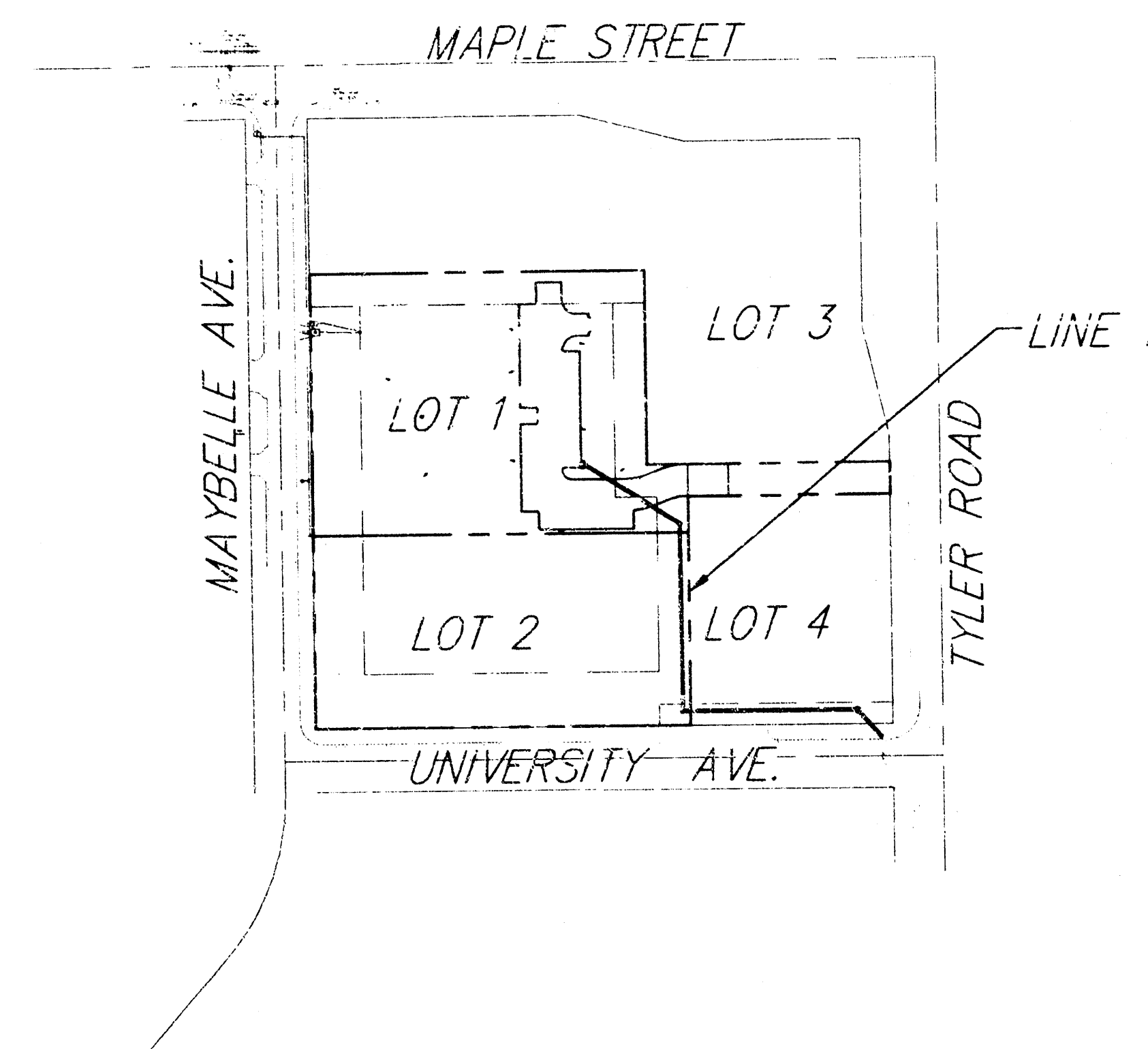
- Contractor will be required to provide a minimum advance notice of forty-eight (48) hours to utility companies prior to starting any excavation as follows:

- One lane of traffic on University to remain open at all times.
- Existing utilities and their location, as shown on the plans, represent the best information obtainable for design. Location information has been obtained from the various utility companies and is either from company record drawings or company-provided field locations. The Contractor will be required to work around existing utilities within the right-of-way which do not conflict with proposed construction.
- The Contractor shall give all property owners and/or tenants of developed property directly abutting the construction of this project a minimum of ten (10) days advance notice prior to start of construction.
- The Contractor shall be responsible for preserving all existing trees. The Contractor will be required to re-establish any property lines which are damaged or destroyed by his construction operations. All trees shall be re-established by a licensed land surveyor in accordance with state laws.
- The Contractor shall obtain the necessary permits from the Office of Central Inspection prior to any roof drain hook-up to the storm water sewer system.
- All work on this project to be in accordance with City of Wichita Standard Specifications dated March 1998. Inlet and manhole construction to be according to standard details on file in the Engineering Division of the City of Wichita.

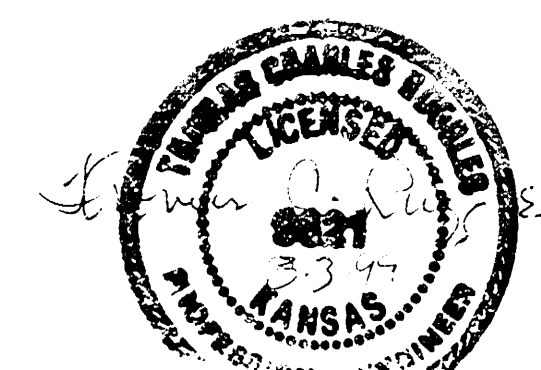

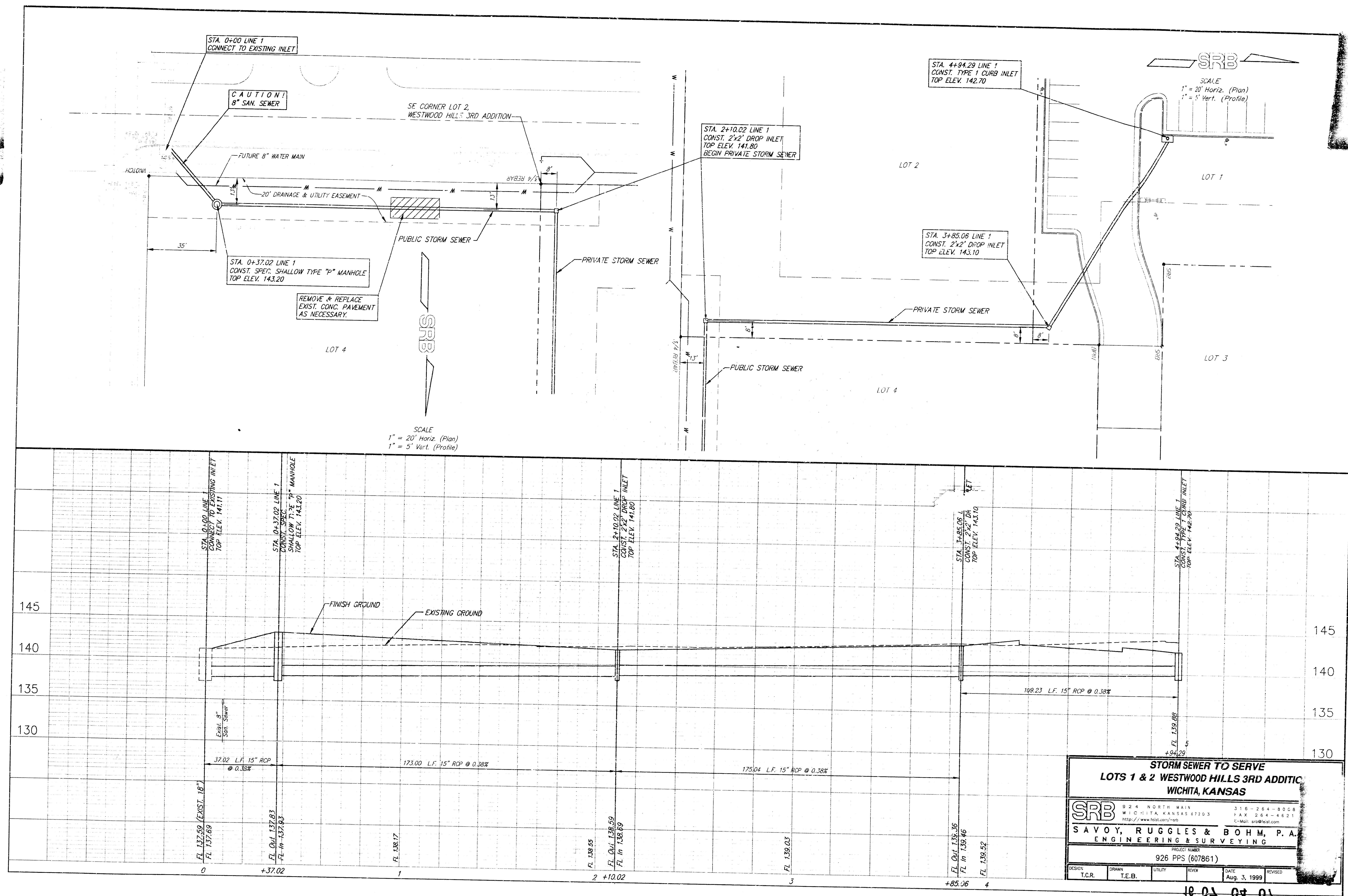
