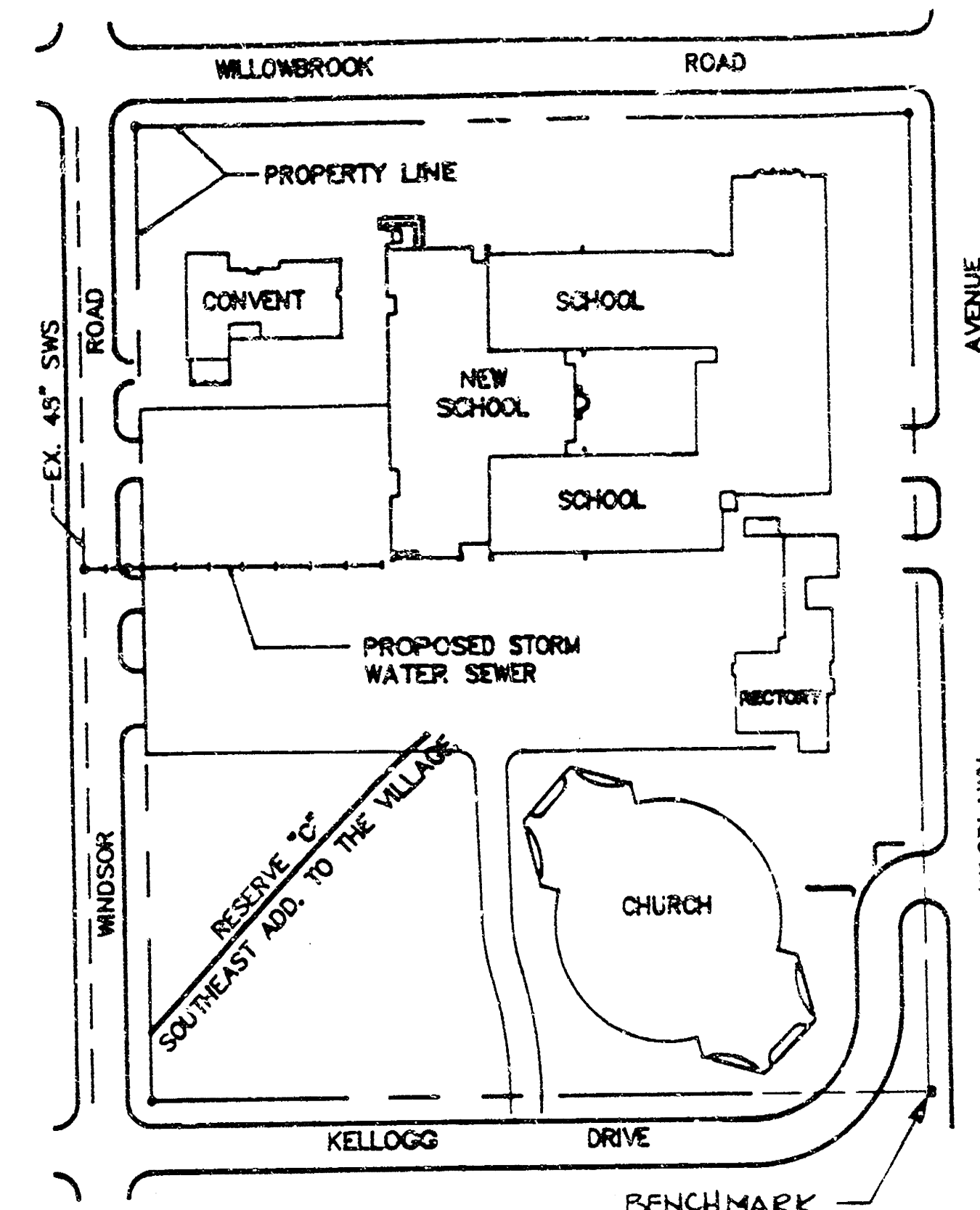

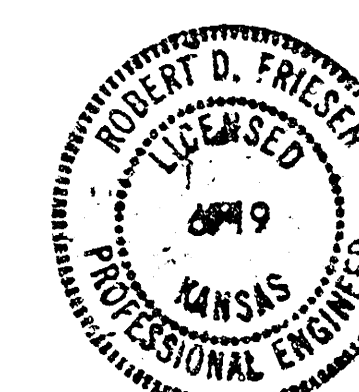

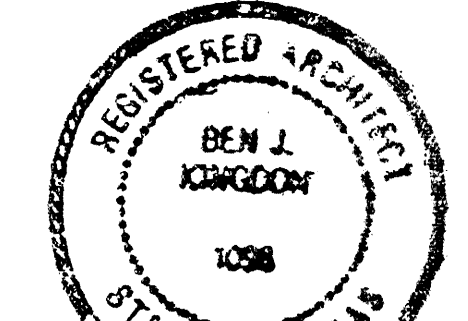
B VICINITY MAP

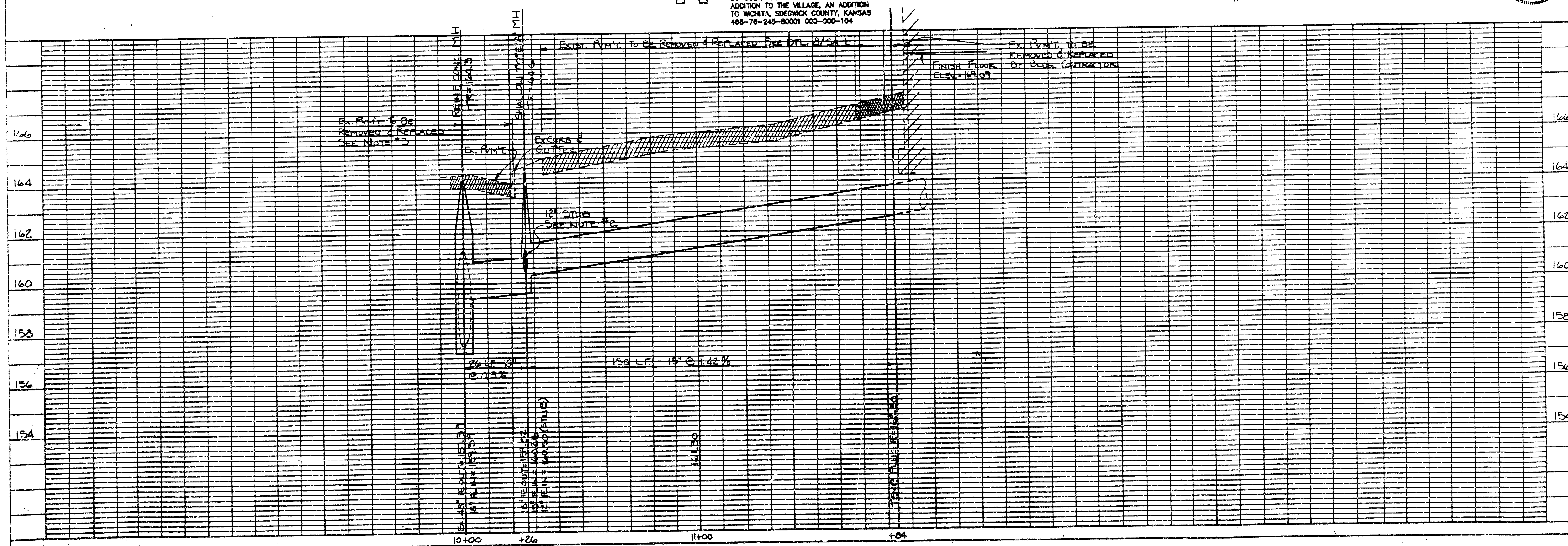

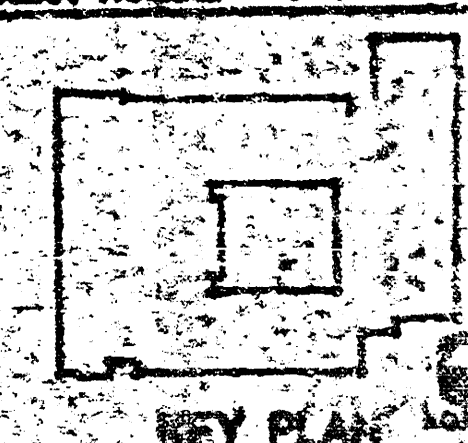
