the undersigned, have caused the land described in the surveyors

ments are hereby granted as indicated for the construction and
maintenance of all public utilities. The street is hereby dedicated to
and for the use of the public. All abutters rights of access to or
from Kellogg St. over and across the north line of Lot 1 and to or
from Edgemoor over and across the east line of Lot 1 and to or
from Marcilene over and across the west line of Lot 1 are hereby
granted to the City of Wichita, provided however that Lot 1 shall
have access to Edgemoor at two locations over all except the north
40 feet of the east line of Lot 1 and shall have access to Marcilene
at one location over all except the south 66.66 feet of the west line
of Lot 1, as shall be determined by the City Engineer of the City of
Wichita, Kansas. The contingent street dedication is hereby dedicat-
ed to and for the use of the public contingent upon the commenc-
ing of the construction of the improvements of the Kellogg and Oliver
Street interchange project.

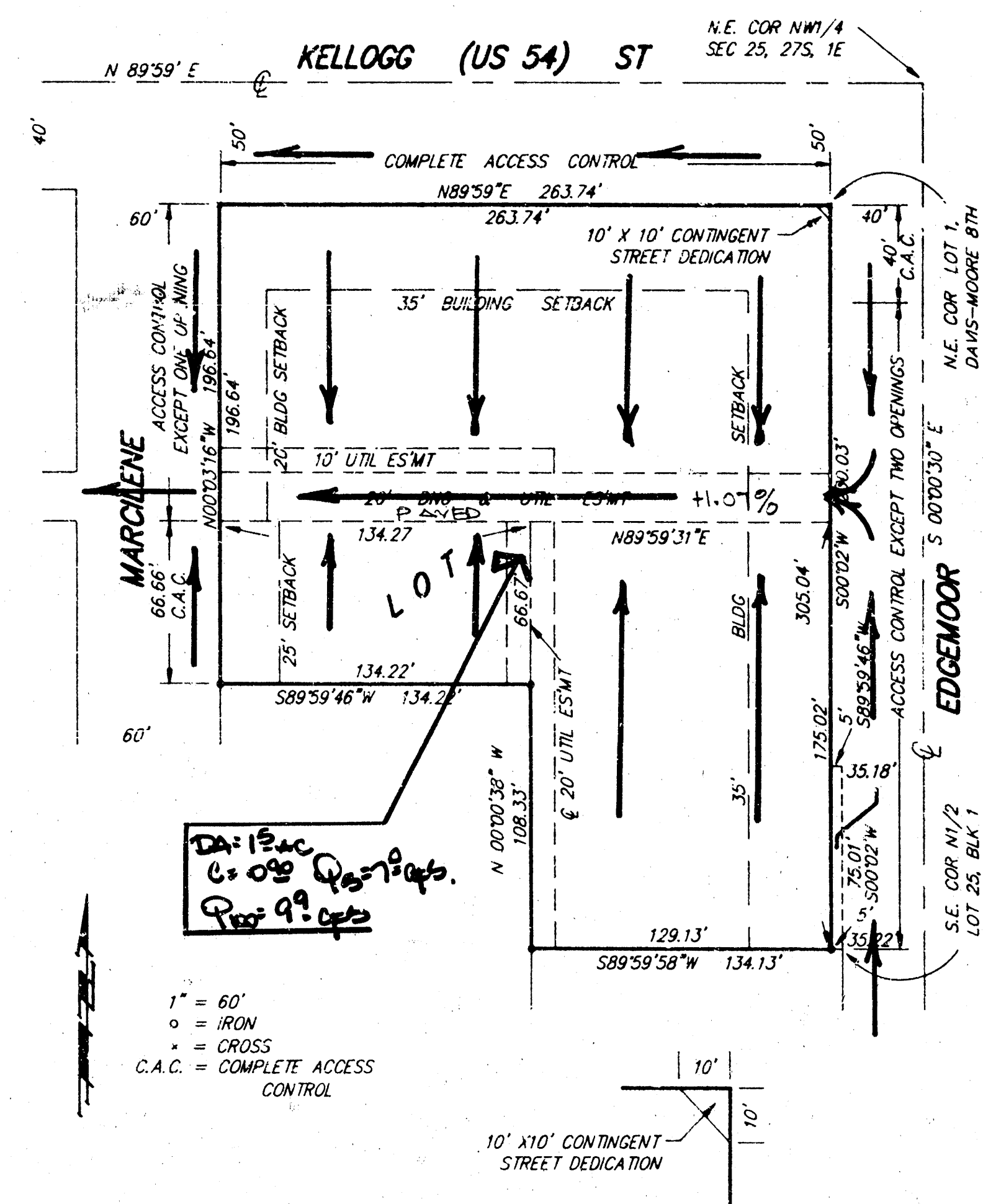
