

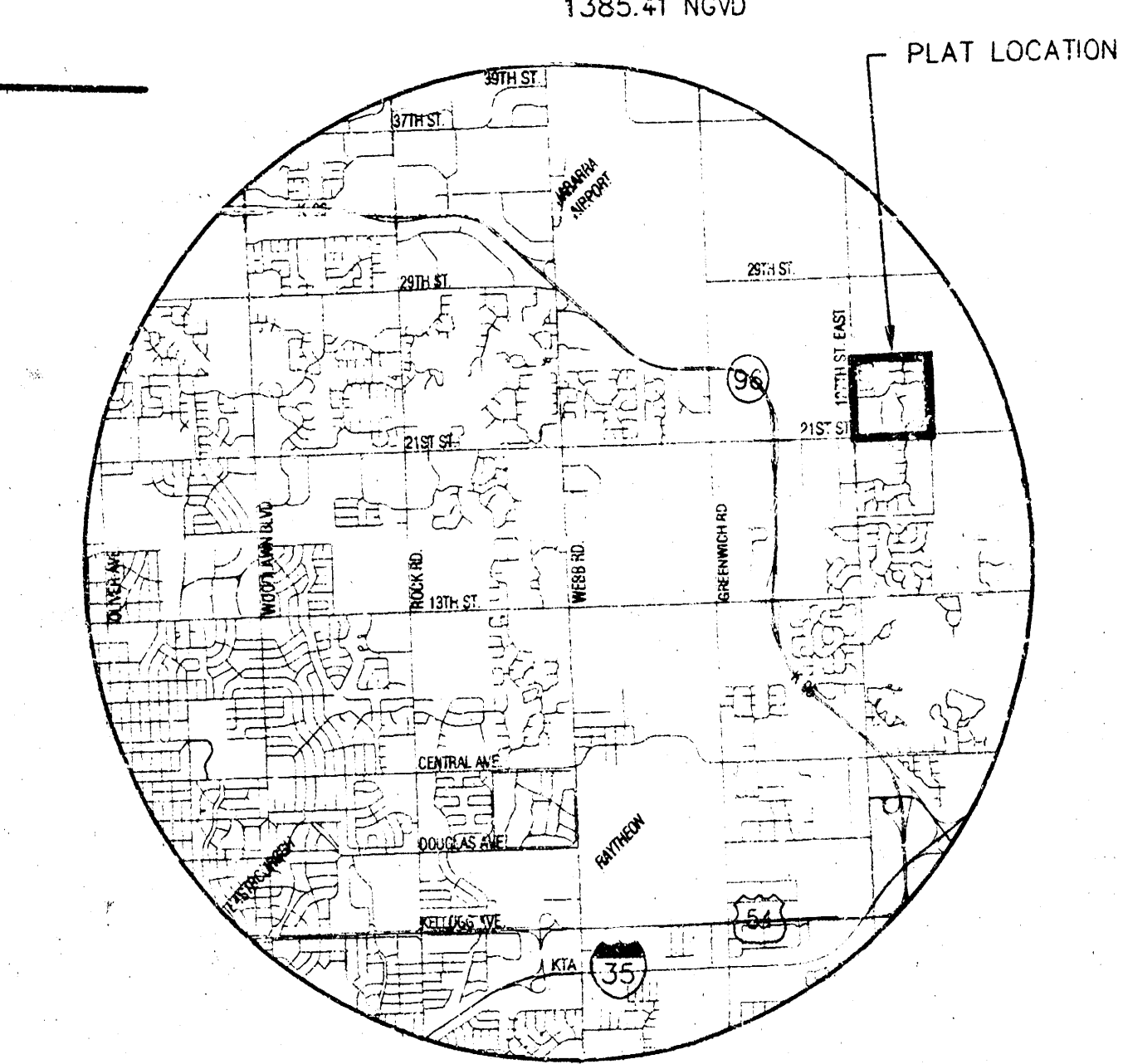


NOTES
