

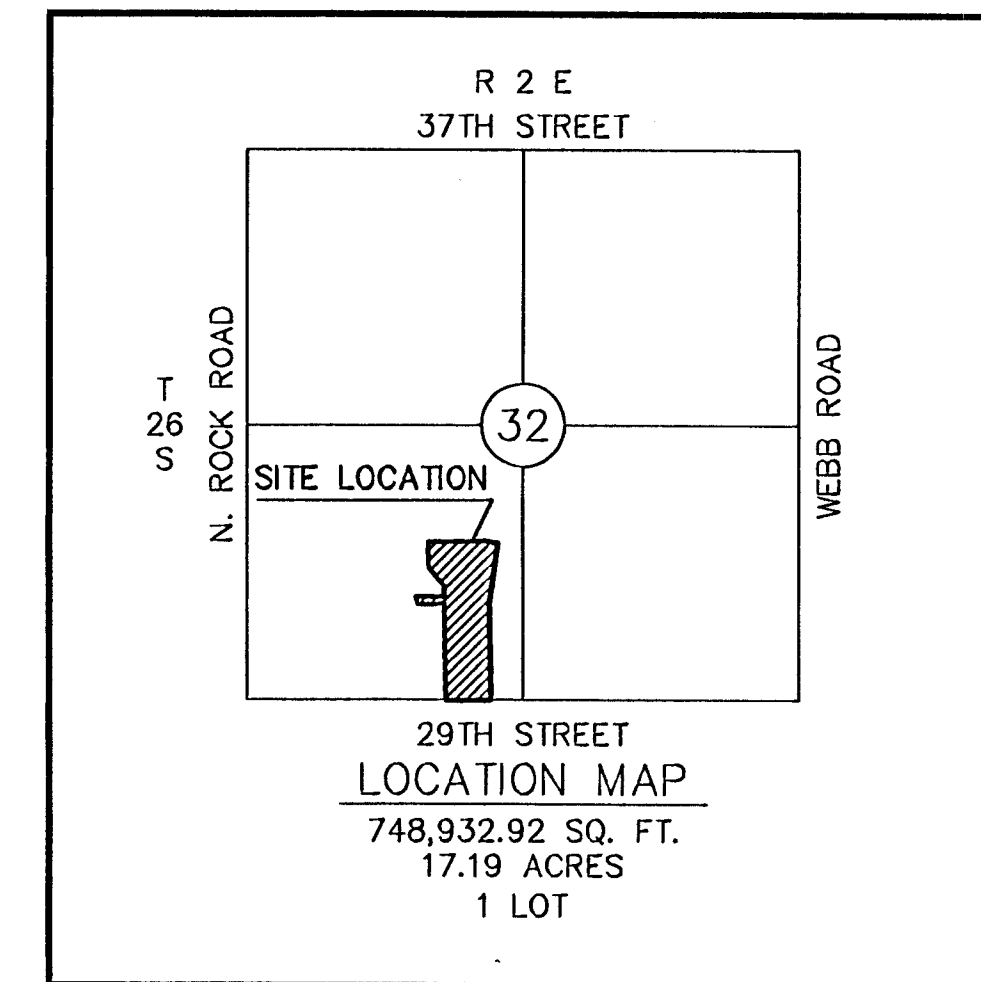

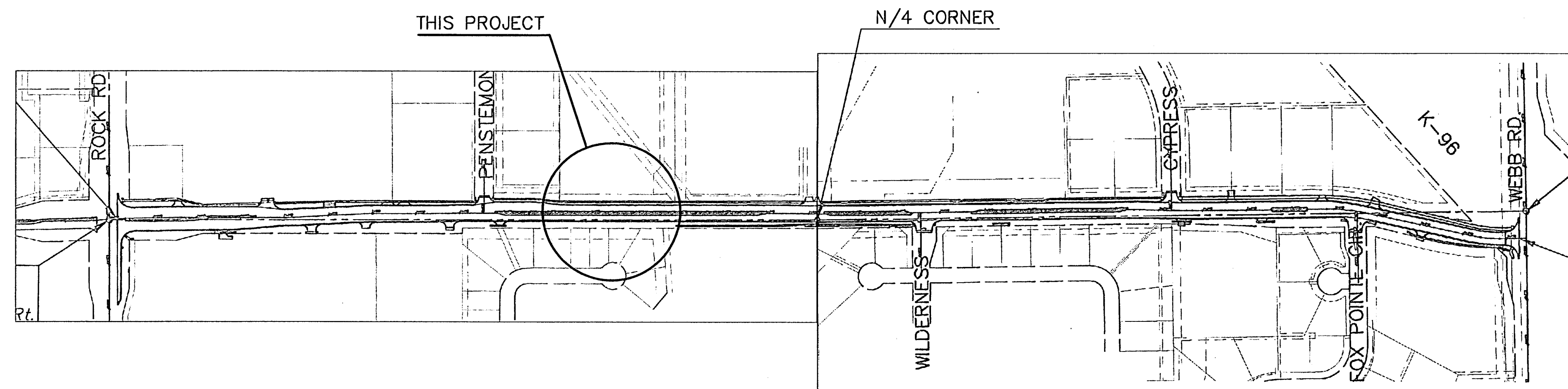

LEGAL DESCRIPTION

Parcel 1  
Lot 16, EXCEPT that part platted as Home Design Center Third Addition, Block 1, Mediterranean Plaza, an Addition to Wichita, Sedgwick County, Kansas.  
Parcel 2  
Lot 17, Block 1, Mediterranean Plaza, an Addition to Wichita, Sedgwick County, Kansas, EXCEPT that portion platted as Home Design Center Addition, an Addition to Wichita, Sedgwick County, Kansas.  
Parcel 3  
That part of Lot 2, Block 1, Home Design Center Addition an Addition to Wichita, Sedgwick County, Kansas described as follows: Commencing at the SE corner of said Lot 2; thence N0°53'18"W along the east line of said Lot 2, 669.93 feet for a point of beginning, said point also being the NE corner of Lot 3, Block 1, Home Design Center Third Addition an Addition to Wichita, Sedgwick County, Kansas; thence continuing N0°53'18"W, 70 feet; thence S89°07'40"W, 275.03 feet to a point on a curve, said point also being the west line of said Lot 2; thence south southeasterly along a curve to the right, having a central angle of 95°4'22" and a radius of 419.25 feet, an arc distance of 72.49 feet, (having a chord length of 72.40 feet bearing S15°30'01"E) to the NW corner of said Lot 3; thence N89°07'40"E, 256.36 feet to the point of beginning.
