Beginning at the northwest corner of said Lot 4; thence southerly along the west lot line to the southwest corner of said Lot 4; thence southerly along the west lot line of said Vacated Alley to the southwest corner of said Vacated Alley; thence southerly along the west lot line of said Lot 3 to a point 20 feet from the northwest corner of said Lot 3; thence easterly parallel to the north lot line of said Lot 3 to a point 8 feet from the west lot line of said Lot 3; thence northwesterly to a point along the north lot line of said Lot 4, a distance of 3.9 feet east of the northwest corner of said Lot 4; thence westerly along the north lot line of said Lot 4 to the point of beginning, containing 1,084 square feet more or less.
