 - Each Lot Area Disturbed by Construction Shall Be the Responsibility of Each Individual Homeowner. Guidelines for the Area.
 - Erosion Control Matting and/or Other Approved Bank Stabilization w/Seeding & Fertilizer Shall be Installed at Engineered Channels or Seemination Areas where the Designed Slopes will be Reduced. Seeding and Fertilizer shall be applied and covered on noted on cover sheet.
 - Install 6" Wide Curlex/Excelsior Blanket, or Approved Equal, on Prepared Surface Back of Curb Edge of Blanket Will Be At Back of Curb. Install Per Manufacturer's Recommendation, Including Slopings.
 - The Earth Dikes Constructed Around the Ponds Shall be Substituted with Silt Fence with Approval of Developer.
 - All Seeding Shall Be Done During Spring or Fall Planting Seasons. Fall Seeding Shall Be From March 15 thru Mid May. Spring Seeding Shall be From March 15 thru Mid May.
 - Install Curlex/Excelsior Blanket, or Approved Equal, on Prepared Surface where Drive Entrances leading into the East Arterial Street.
