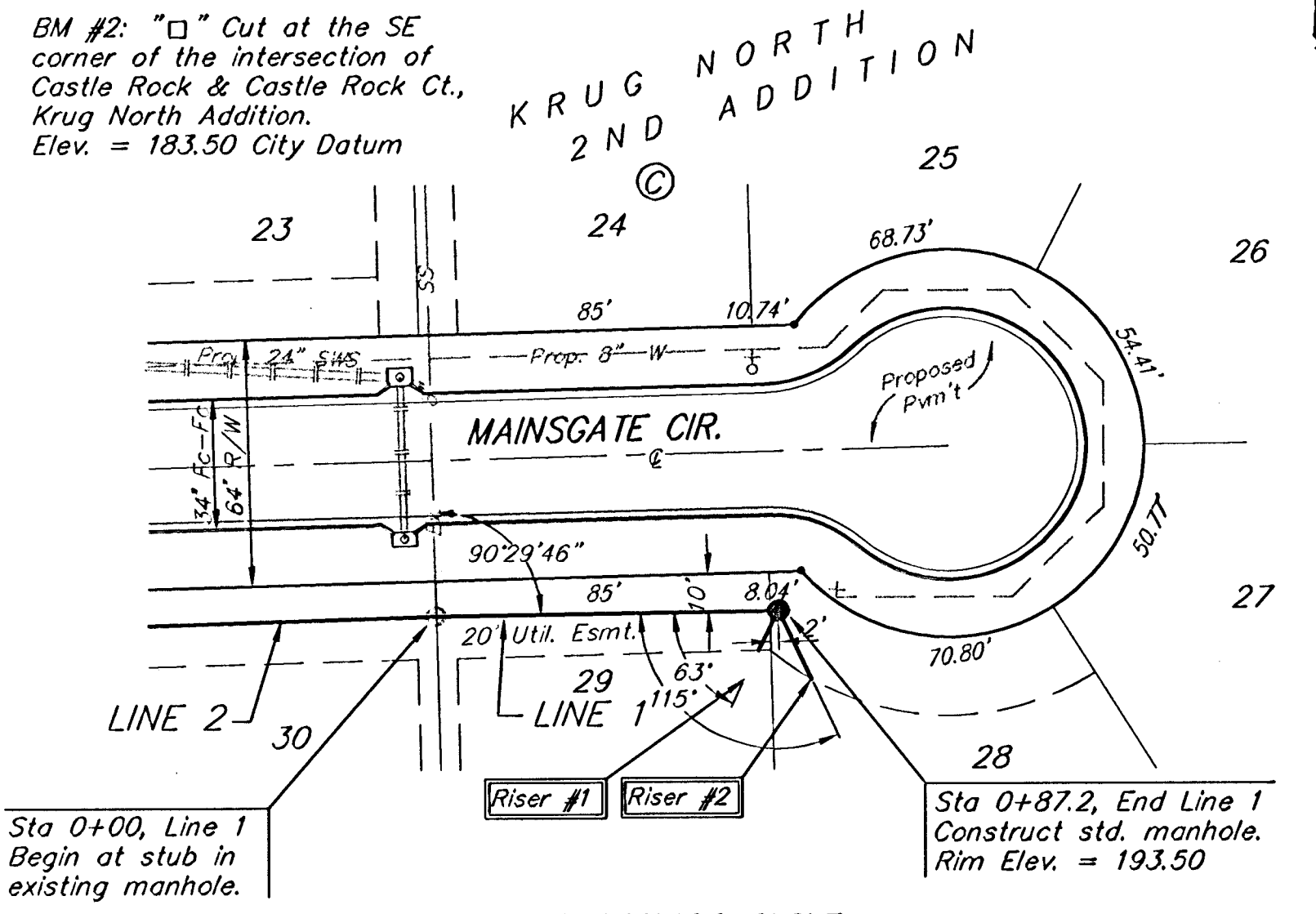

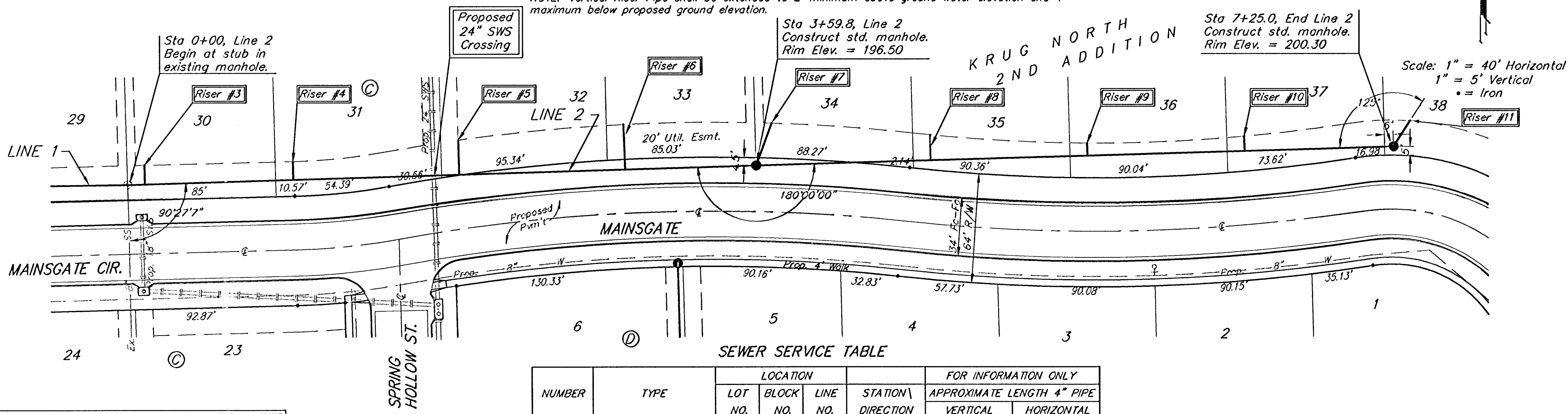
NOTE: Vertical Riser Pipe shall be extended to 2' minimum above ground water elevation and 4' maximum below proposed ground elevation.

All trench and manhole excavation areas from Sta. 0+00 to Sta. 0+87.2, Line 1 & Sta. 0+00 to Sta. 7+25.0, Line 2 shall be backfilled with sand. The sand backfill shall be within two feet of existing grade and shall be water-jetted and vibrated during backfilling. All costs shall be subsidiary to pipe cost.

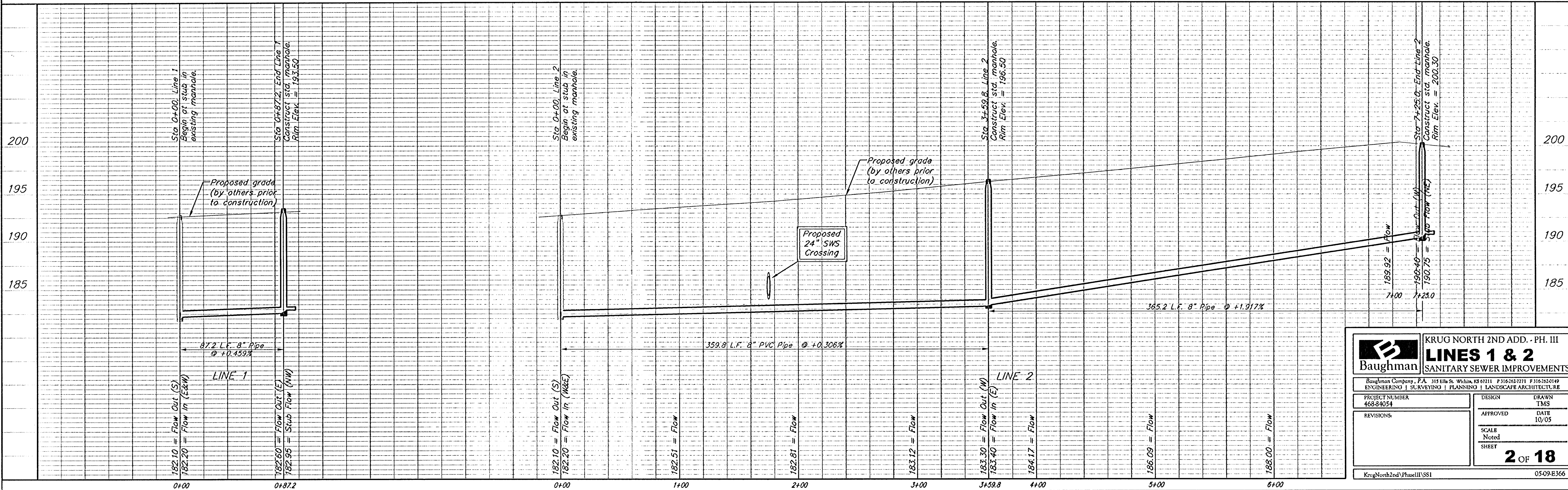
