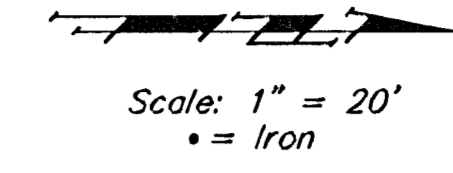


BENCHMARKS:

 Elev. = 189.19 (City Datum)



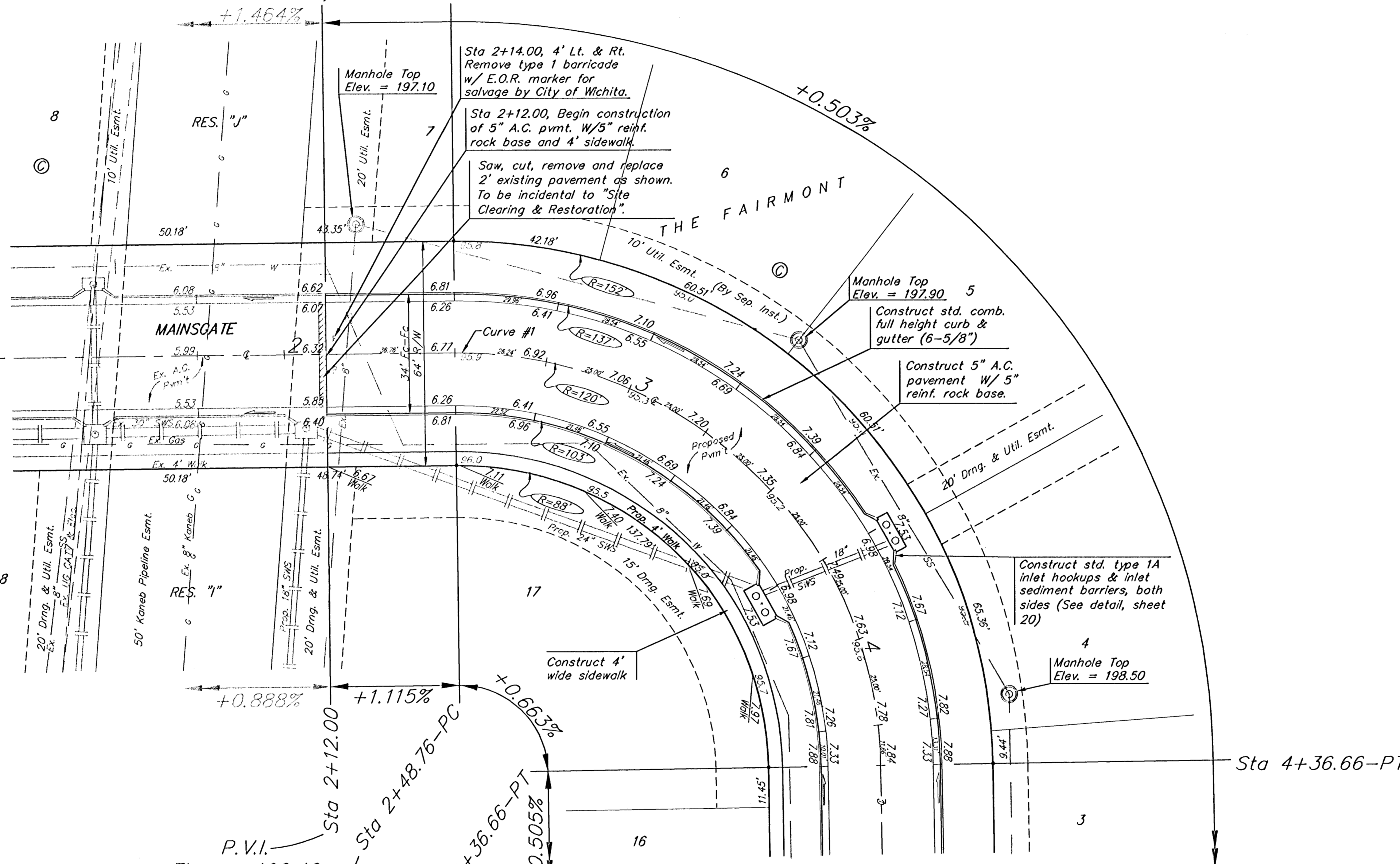
