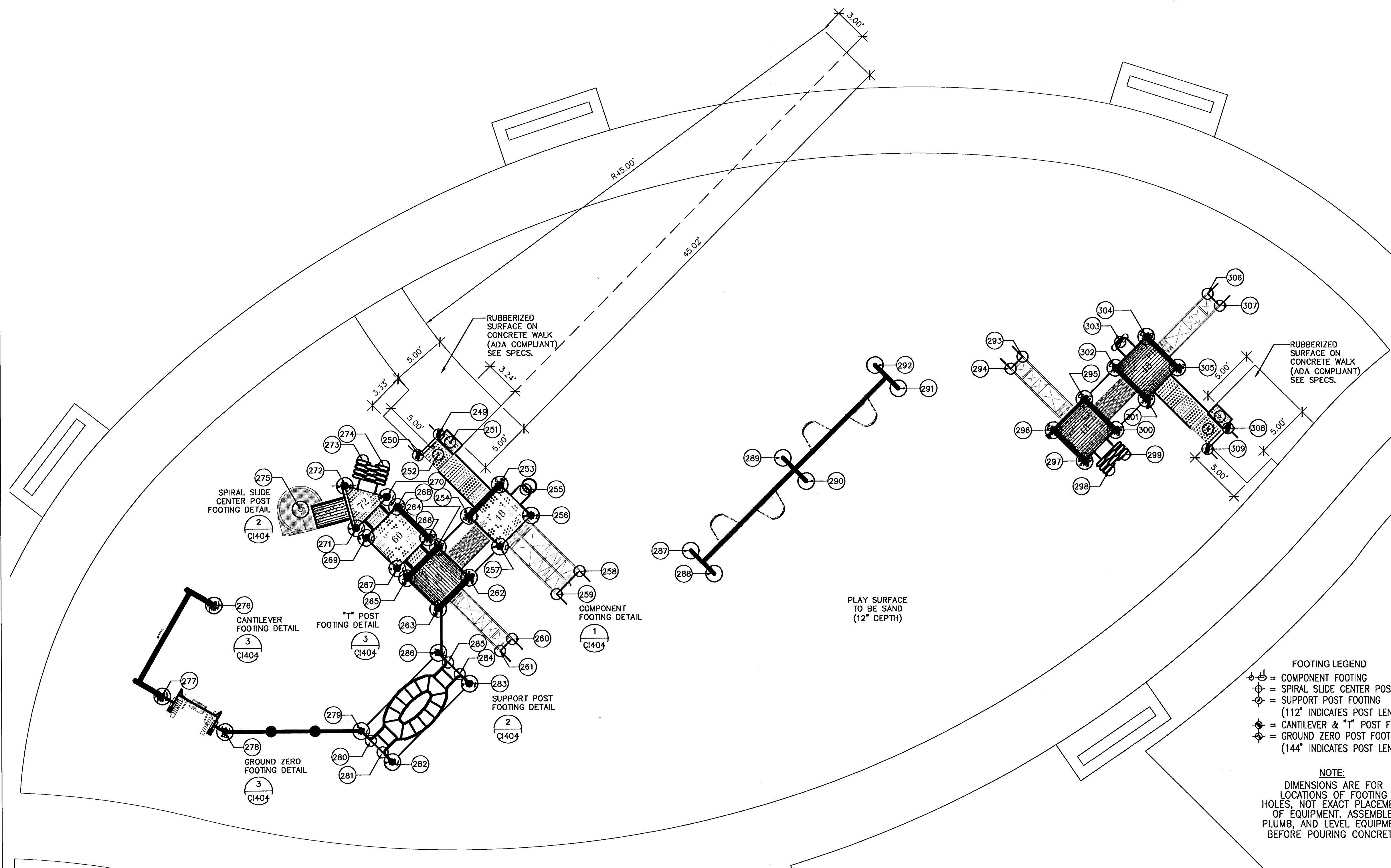

NOTES

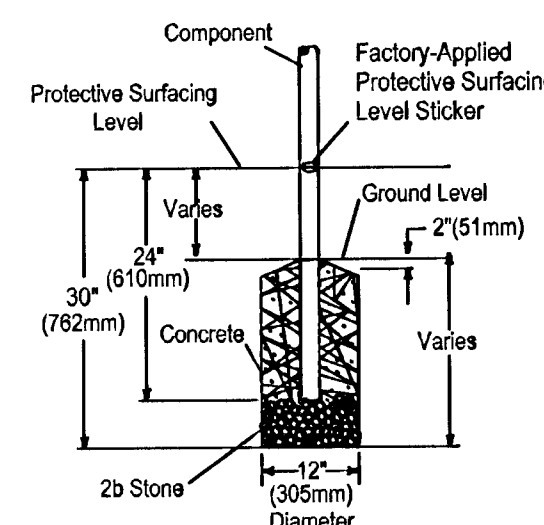
- THE SITE PLAN PROVIDED MUST BE CHECKED AGAINST THE ACTUAL SITE AREA TO INSURE THAT THE PLACEMENT OF YOUR STRUCTURE MEETS THE REQUIRED CLEARANCES.
- THERE MUST BE A MINIMUM DISTANCE OF 6' BETWEEN ANY OBSTACLE, SIDEWALK, ETC., AND YOUR STRUCTURE.
- SWINGS MUST HAVE A MINIMUM DISTANCE EQUAL TO 2 TIMES THE SWING TOP RAIL HEIGHT IN FRONT OF AND BEHIND THE TOP RAIL. (EX: FOR SWINGS WITH 8' HIGH TOP RAIL, MUST HAVE 16' IN FRONT OF AND BEHIND THE TOP RAIL - 32' TOTAL.)
- SLIDES MUST HAVE A MINIMUM DISTANCE AT THE EXIT CHUTE EQUAL TO THE HEIGHT OF THE SLIDE PLUS 4'. (EX: FOR A 4' HIGH SLIDE, THE DISTANCE EQUALS 8'.)
- THE COMPLETE AREA, INCLUDING THE SPACE UNDER AND AROUND THE EQUIPMENT, MUST BE COVERED WITH AN IMPACT ATTENUATING MATERIAL. SEE THE 1991 PUBLICATION OF "HANDBOOK FOR PUBLIC PLAYGROUND SAFETY" PUBLISHED BY THE U.S. CONSUMER PRODUCT SAFETY COMMISSION FOR GUIDELINES AND RECOMMENDATIONS ON THE TYPE AND DEPTH OF SURFACING MATERIAL. - PAVED SURFACES, SUCH AS ASPHALT AND CONCRETE, ARE NOT ACCEPTABLE FOR USE UNDER YOUR STRUCTURE.
- IT IS THE CONSUMER'S RESPONSIBILITY TO CHECK WITH LOCAL UTILITIES PRIOR TO EXCAVATING FOOTINGS FOR ANY UNDERGROUND UTILITY LINES THAT MAY EXIST WITHIN THE INSTALLATION AREA.
- IT IS THE CONSUMER'S RESPONSIBILITY TO CHECK LOCAL SOIL CONDITIONS AND DRAINAGE WITHIN THE SITE AREA. INQUIRE WITH LOCAL CONTRACTORS FOR APPROPRIATE RECOMMENDATIONS.
- READ COMPLETELY THE INSTALLATION INSTRUCTIONS PROVIDED WITH YOUR STRUCTURE PRIOR TO BEGINNING CONSTRUCTION.

PLAY AREA LAYOUT PLAN



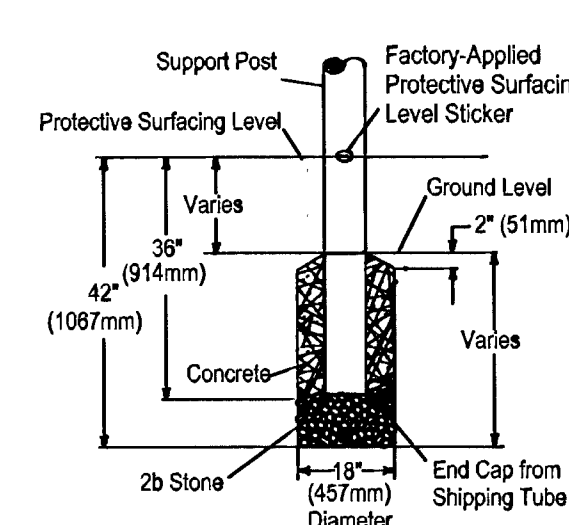

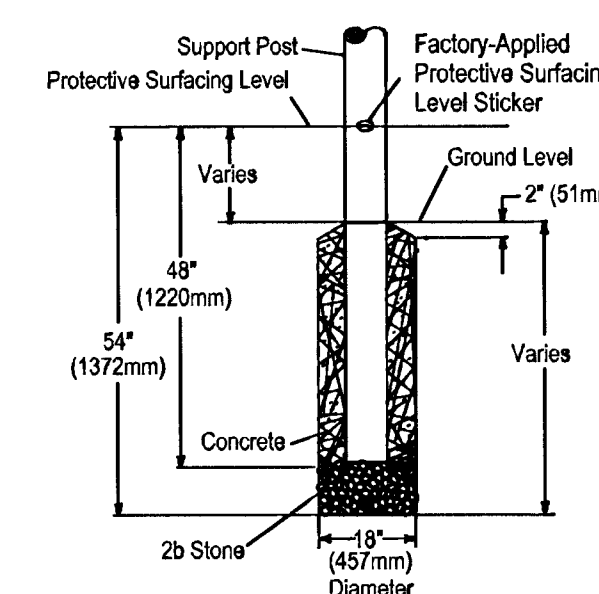
1 COMPONENT FOOTING
