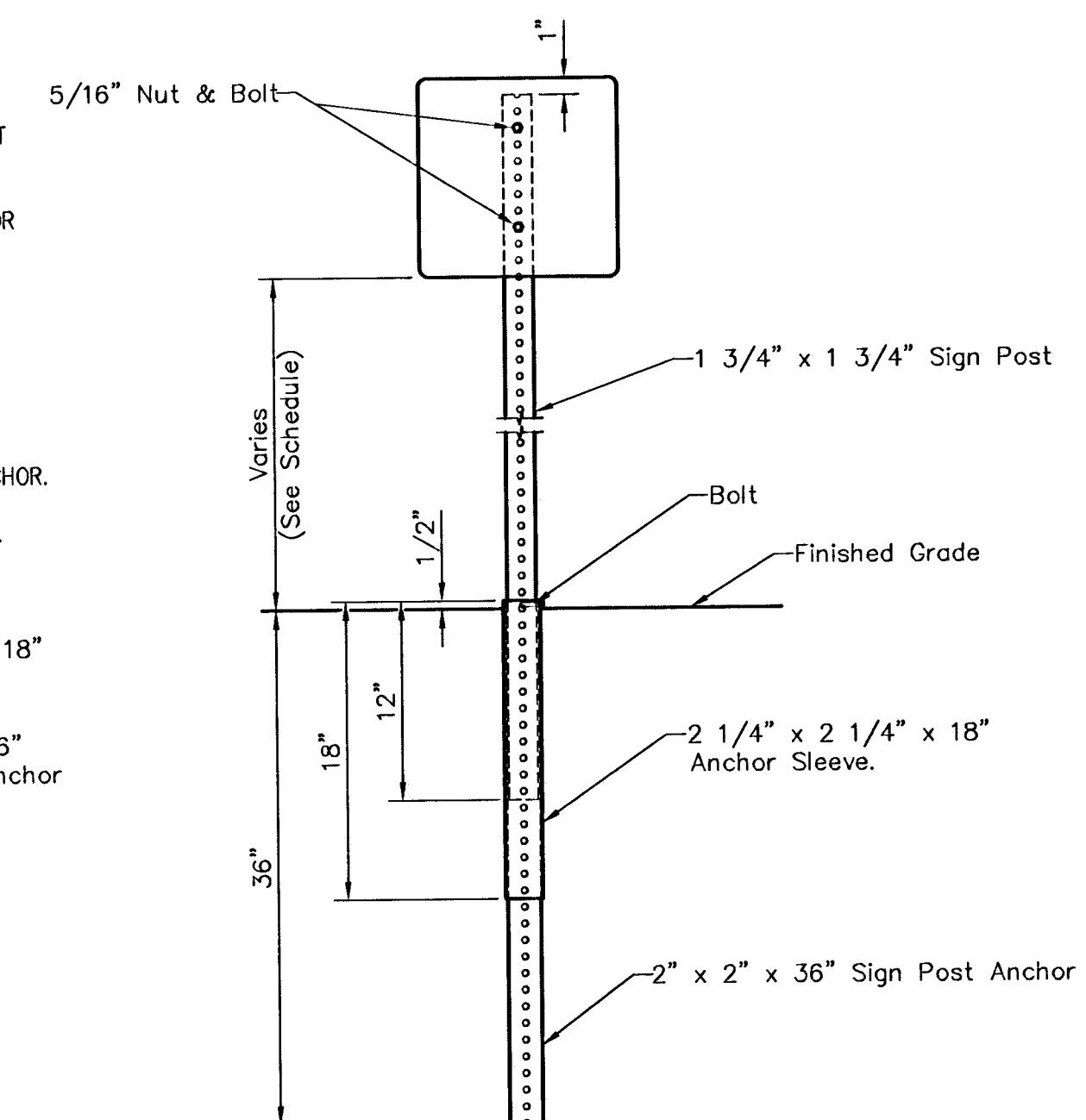

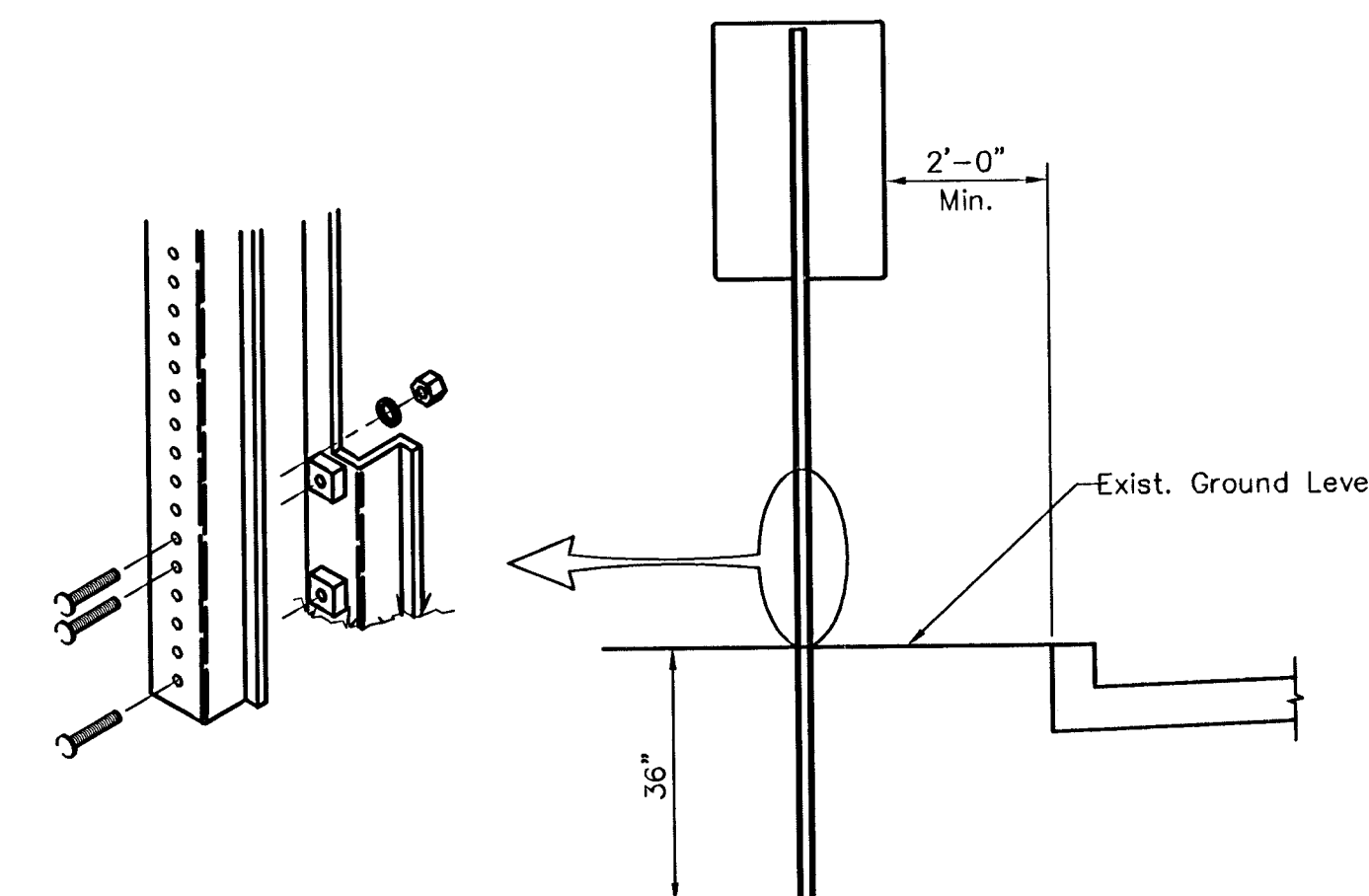


NOTES:

ALL BOLTS AND NUTS FOR FASTENING THE SIGNS AND SIGN POST ASSEMBLY SHALL COMPLY WITH SECTION 1614 AND ALL WASHERS SHALL COMPLY WITH SECTION 1614 OF THE STANDARD SPECIFICATIONS FOR STATE ROAD AND BRIDGE CONSTRUCTION (1980 EDITION) AND SHALL BE SUBSIDIARY ITEM.

ALL LETTER, NUMBER & SYMBOL SIZES, SPACING & COLORS AND SIGN COLORS SHALL CONFORM TO THE CURRENT "MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES."

ALL SIGN MATERIALS TO BE 0.080" ALUMINUM.



TRAFFIC SIGN INSTALLATION DETAIL

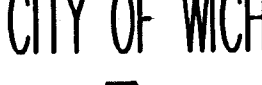
